

**NEVADA COUNTY BOARD OF SUPERVISORS
IS SEEKING INTERESTED PERSONS TO SERVE ON THE FOLLOWING:**

***ADULT AND FAMILY SERVICES COMMISSION:** (4 vacancies) Four Private Sector vacancies; two to fill 2-year unexpired terms ending April 30, 2019, and two to fill 2-year unexpired terms ending April 30, 2020. This Commission shall operate under the Nevada County Board of Supervisors as the primary advisory body relative to health and human service's needs, and performs the responsibilities of the Board of Directors as described under Title 42 USC Chapter 106 § 9910 - Tripartite Boards. ***AGRICULTURAL ADVISORY COMMISSION:** (1 position) One Agricultural Interests representative to fill a 4-yr. term unexpired term ending March 30, 2019. The Commission shall advise the Board of Supervisors on matters concerning the agricultural resources of the County, develop a framework for cooperation among agencies and institutions, interest groups, individuals, public and private property owner, and all others for wise conservation and management of resources to benefit the County's agricultural assets, and maintain an active Agricultural Commission to advise the County on agricultural-related matters. ***AIRPORT COMMISSION:** (1 position) One member appointed by District IV supervisor from among residents of the County at-large. The Commission shall have the following powers and duties: to advise the Board of Supervisors on the planning, maintenance, development and operation of the airports and airport facilities which are, or will be, owned, controlled or leased by the County; to study and to make recommendations on the subject of developing the airports and airport facilities in Western Nevada County; to formulate and to recommend to the Board of Supervisors the general policies relating to the purposes of the Airport Commission; to work with the CEO in the preparation of the preliminary and final budget to submit to the Board annually, providing for the costs of maintenance, operation and improvement for the ensuing fiscal year; and to study and to make recommendations on the subject of funds available to the County for the Development of the airports and airport facilities from Federal, State and other sources. ***AREA 4 AGENCY ON AGING ADVISORY COUNCIL:** (1 vacancy) One Board of Supervisors appointed representative. The Advisory Council shall advise the area agency on all matters relating to development and administration of the Area Plan and operations conducted thereunder. ***ASSESSMENT APPEALS BOARD:** (1 vacancy) One alternate member to fill an unexpired 1-year term ending September 30, 2019. Specific qualifications are required per Section 1624 of the Revenue and Taxation Code. The function of the Appeals Board is to determine the full value of property or to determine other matters of property tax assessment over which the Appeals Board has jurisdiction. The Board acts in a quasi-judicial capacity and renders its decision only on the basis of proper evidence presented at the hearing. The functions of the Board are outlined in Section 1620 et seq. of the Revenue and Taxation Code. Compensated per Administrative Code Chapter II, Article 13.11. ***KINGSBURY GREENS COMMUNITY SERVICES DISTRICT:** (1 vacancy) One resident of Kingsbury Greens CSD to fill an unexpired term ending December 4, 2020. The District shall provide for the collection, treatment, and disposal of sewage, waste and storm water of the district and its residents. MENTAL HEALTH AND SUBSTANCE USE ADVISORY BOARD: (4 vacancies) This Board reviews and evaluates the community's mental health needs, services, facilities, and special problems; reviews any County agreements entered into pursuant to Welfare and Institutions Code Section 5650; advises as to any aspect of the local mental health program; reviews and approves the procedures used to ensure citizen and professional involvement at all stages of the planning process; and submits an annual report to the Board of Supervisors. NEVADA COUNTY SANITATION DISTRICT NO. 1 ADVISORY COMMITTEE: (7 vacancies) One Lake of the Pines Zone 2 representative position, one Lake of the Pines Zone 2 alternate position, one Gold Creek Zone 5 representative and one Penn Valley Zone 6 representative position, all to fill unexpired 2-year terms ending June 30, 2020; one Cascade Shores Zone 8 representative, one Cascade Shores Zone 8 alternate, and one Eden Ranch Zone 9 representative, all to fill 2-yr. unexpired terms ending June 30, 2019. Members shall be property owner representatives. The Board of Directors of the Nevada County Sanitation District No. 1 appoints the members. ***SEWAGE DISPOSAL TECHNICAL ADVISORY GROUP:** (2 vacancies) One consultant appointed by District IV Supervisor, and one consultant appointed by District V Supervisor, each selected from the County-at-large to serve at the pleasure of the appointing Supervisor. Consultant is defined in County of Nevada On-Site Sewage Disposal Ordinance 1975 as one of the following; Certified Engineering Geologist, Certified Professional Soil Scientist, Registered Civil Engineer, Registered Environmental Health Specialist, or Registered Geologist. Said group members may not be employees of the County of Nevada. Each group member will be qualified by experience and training to pass on matters pertaining to sewage disposal. The purpose will be to review and recommend proposed revisions and additions to the sewage disposal regulations or sewage disposal ordinance in an advisory capacity; review and recommend new methods, techniques, and materials for on-site sewage disposal, in an advisory capacity; and serve as an appeal body under the provisions of Section A-032 of County Resolution 98-217. ***SOLID AND HAZARDOUS WASTE COMMISSION (NEVADA COUNTY):** (2 vacancies)
