To Whom It Concerns;

Because I am rarely available to go to BOS meetings, as I am currently interim President of an HOA and have multiple responsibilities as a CA PHN, I am forwarding, as promised back in November 2022 (and referenced back to June 2022), my radar information related to speeding into town on Brunswick.

I bet you a dollar that if the powers that are spent one hour mid morning, close to 11 am to 1 pm, and then 4 pm to 5:30 pm, and wrote tickets, you could actually pay the salary of an officer or two just doing tickets part time. That could actually turn out to be full time after the 235 homes on the way to Loma Rica are completed, with another 300+ cars, trucks, etc. start flooding our roadways.

As the weather begins to improve there will be more traffic, more speeders, more accidents, and maybe even something serious enough for you all to do something about the problem, like a death or serious injury, and then a lawsuit for the city not taking action.

I have suggested lowering the speed coming into town to at least 35, if not 30. Folks are speeding to catch the green light, if it exists, and then end up sitting at the light, anxious as all get out to speed onward.

There are multiple entrances and exits to businesses starting from the River Valley Community bank all the way to the Safeway shopping center, and the new homes on the south side (heading out of town) across from those businesses, that need protection.

After 4.5 years of no police presence, with radar, speeders (many of them large trucks, tankers, and 16 wheelers hauling heavy materials and machinery) have become very brazen.

There are also a couple of other problems with the Sutton-Brunswick intersection that need addressing. That is another discussion needing to be ameliorated.

Thank you for taking the time to view this information. My previous emails (sent on 6/15 and 11/4/2022) mentioned these issues and the November email stated that the average speed was 54 mph. Nothing has changed, but somebody's life will be irrevocably changed if no action is taken.
