SUBJECT: Resolution Directing the Nevada County Clerk-Recorder/Registrar of Voters to Consolidate the Community Facilities District No. 1 (Truckee Library) of The Truckee Library Joint Powers Authority Special Bond Measure Election With The November 4, 2025 California Statewide Special Election And Directing The Clerk-Recorder/Registrar Of Voters To Seek Reimbursement For Administering The Elections In Accordance With State Elections Laws Governing Elections Costs

RECOMMENDATION: Adopt the Resolution.

FUNDING: Costs for this special election were not included in the FY 25/26 department budget. Revenue sources to offset the costs are as follows:

- The Community Facilities District No. 1 (Truckee Library) of the Truckee Joint Powers Authority shall reimburse the County for its prorated share of costs incurred by the County elections official, in accordance with Elections Code section 10520, in addition to the costs already incurred prior to consolidation with the California Statewide Special Election.
- Senate Bill 280 appropriated an amount from the General Fund to the Controller for the actual and reasonably necessary costs for counties to conduct the special election, as determined by the Director of Finance. Any excess funds received by the County shall be used to offset state costs for the next statewide election conducted by the County.

A budget amendment will be requested after all costs have been determined.

BACKGROUND:

Truckee Library JPA. On June 23, 2025, our office received two resolutions from the Truckee Library JPA and the newly formed "Community Facilities District No. 1 (Truckee Library) of the Truckee Library Joint Powers Authority." Resolution 2025-04 and Resolution 2025-05 both called a special election to take place on November 4, 2025 for the purpose of levying a tax on the Community Facilities District No. 1 (Truckee Library) of the Truckee Library Joint Powers Authority. The JPA has also requested the county election officials of Placer County and Nevada County conduct the special election for voters in the jurisdiction of Community Facilities District No. 1 (Truckee Library) of the Truckee Library Joint Powers Authority. A map of the jurisdiction has been provided to our office. JPA Resolution 2025-04 also authorizes the JPA to fully reimburse the County elections office for election services rendered.

On July 22, 2025, the Nevada County Board of Supervisors approved Resolution 25-377 authorizing the Nevada County Clerk-Recorder/Registrar of Voters to render services for the

Community Facilities District No. 1 (Truckee Library) of the Truckee Library Joint Powers Authority special election to be held on November 4, 2025.

Statewide Special Election. As part of a legislative redistricting package, on August 21, 2025 the California State Legislature passed, and the Governor of California approved, Senate Bill 280, which called a Statewide Special Election to take place on November 4, 2025. SB 280 was an urgency statute which took effect immediately upon the Governor's signing.

SB 280 permits any special district that called a special election to consolidate with the California Statewide Special Election, provided that the special local election was called on or before August 8, 2025. Because the special election of the Community Facilities District No. 1 (Truckee Library) of the Truckee Joint Powers Authority was called on June 23, 2025, that election meets all the elements necessary to consolidate with the California Statewide Special Election.
