SUBJECT: Award of Contract for Newtown Road Overlay Project 2016 Contract No.

400024 - Districts 1 and 4

RECOMMENDATION: Approve the attached Resolution.

<u>FUNDING</u>: The project is budgeted in Fiscal Year 2016/17 and impacts the Road Capitol Improvement Project (CIP) budget. Funding is provided through Measure "F" and Regional Transportation Program (RSTP). There is no impact to the County's General Fund and no budget amendment is needed.

BACKGROUND:

On April 12, 2016, the Nevada County Board of Supervisors adopted Resolution No. 16-148 that approved the plans, specifications and cost estimate for the subject project and instructed the Clerk of the Board of Supervisors to advertise for bids. The bids were opened on May 12, 2016, at 3:00 p.m. and are listed below:

Award is recommended for the contract work to the low bidder, Baldwin Contracting Company, dba Knife River Construction at the bid price of \$401,801.10. The total amount to be encumbered is \$441,981.21, which includes a 10 percent contingency. Funds are available for the project. This contract provides for placement of an asphalt concrete overlay, reinforcing fabric and traffic stripes on approximately 2.6 miles of Newtown Road.

Construction is scheduled to begin in August/September 2016, and be completed within 25 working days, as allowed for in the contract. This contract must be awarded on June 14, 2016 in order to meet bid to contract requirements and the contract is subject to budget appropriations to be approved by the Board of Supervisors on June 21, 2016.
