RESOLUTION AUTHORIZING AMENDMENT TWO OF A BOARD CONTRACT BETWEEN THE COUNTY OF NEVADA AND VAN DERMYDEN MADDUX LAW CORPORATION

WHEREAS, this amendment is executed this 13th day of June, 2017 by and between Van Dermynen Maddux Law Corporation and County of Nevada. Amendment Two will amend the prior agreement between the parties dated November 1, 2016 executed by the County Purchasing Agent for administrative investigative services, PESK3252 and amended by Resolution 17-057 effective January 24, 2017.

WHEREAS, the County wishes to amend this Board approved contract in order to allow for continued services; and,

WHEREAS, the parties desire to amend their agreement to increase the contract amount from \$60,000 to \$62,258, to allow for payment of services to be provided; and,
