



RESOLUTION No. 25-033

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION DELEGATING AUTHORITY TO THE COUNTY EXECUTIVE OFFICER OF NEVADA COUNTY TO GIVE NOTICES TO THE CITY OF NEVADA CITY AND THE TOWN OF TRUCKEE AS REQUIRED BY GOVERNMENT CODE SECTION 25351

WHEREAS, Government Code section 25351(a) provides that a county Board of Supervisors may construct, expand, lease, build, rebuild, refurbish or repair public buildings as are necessary to carry out the work of the county government; and

WHEREAS, Government Code section 25351(b) provides that whenever a Board of Supervisors of a county decides to go out to bid to construct a county building, expand an existing building, expand the use of an existing building, or enter into a lease of an existing building within the incorporated territory of a city within the county, the Board of Supervisors shall notify in writing, at least 60 days prior to going out to bid or entering into a lease, the city clerk of the city where the building is going to be constructed, expanded, or leased; and

WHEREAS, Government Code section 25351(c) provides that in instances where the Board of Supervisors is exempt from the bidding process, the Board of Supervisors shall notify the city clerk sixty (60) days prior to the construction, expansion, or leasing of a building; and

WHEREAS, Government Code section 25351(d) provides that the sixty (60) day notification requirements may be waived if the city council consents, by resolution; and

WHEREAS, in order to expedite the process of bidding on, constructing, expanding, and/or leasing buildings within the city limits of the City of Nevada City and the Town of Truckee, the Board of Supervisors of Nevada County desires to delegate its authority to provide notice to the City of Nevada City's clerk and the Town of Truckee's clerk to the County Executive Officer of Nevada County, or their designee.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Nevada hereby delegates its authority to provide notice pursuant to Government Code section 25351 to the City of Nevada City's clerk and the Town of Truckee's clerk regarding the bidding process, construction, expansion, expansion of use, or leasing of any County building within those cities' limits to the County Executive Officer of Nevada County, or their designee.
