


#### TRUTH ACT

- TRANSPARENT REVIEW OF UNJUST TRANSFERS AND HOLDS
- APPROVED BY GOVERNOR BROWN ON SEPTEMBER 26, 2016
- REQUIRES NCSO TO PROVIDE AN INMATE A WRITTEN CONSENT FORM PRIOR TO ICE INTERVIEW
- NCSO ESTABLISHED POLICIES AND PROCEDURES
  - CORRECTIONS POLICY 502
  - ADDRESSES REQUIREMENTS OF GOVERNMENT CODE 7283-7283.2 AND 7282.5

### **GOVERNMENT CODES**

- GOVERNMENT CODE 7282.5
  - IDENTIFIES CHARGES INMATES CAN BE HELD BY ICE
- GOVERNMENT CODE 7283
  - DEFINES WHICH INMATES TO INCLUDE DURING COMMUNITY FORUM
- GOVERNMENT CODE 7283.1
  - OUTLINES PROCESS (PROVIDING FORMS, INFORMATION AVAILABILITY, COMMUNITY FORUM)
- GOVERNMENT CODE 7283.2
  - SPECIFIES CHAPTER DOESN'T CHANGE AUTHORITY TO DETAIN PER ICE



## NCSO POLICY 502.3

- INMATE RECEIVES COPY OF ICE REQUEST AS WELL AS ONE OTHER PERSON DESIGNATED BY INMATE (E.G. AN ATTORNEY)
- NOTIFY INMATE IF JAIL PLANS ON COMPLYING
- CONSENT FORM HAS TO BE AVAILABLE IN SEVERAL DIFFERENT LANGUAGES
- JAIL KEEPS A COPY, INMATE RECEIVES ORIGINAL
- ALL DOCUMENTS AND COMMUNICATIONS ARE PUBLIC RECORD

## **PROCESS**

- INMATE IS BOOKED INTO WBCF
- ICE IS NOTIFIED VIA LIVESCAN
  - SEND DETAINER TO WBCF
- DETAINER FORM IS COMPLETED
- NOTIFICATION AND CONSENT FORMS ARE GIVEN TO INMATE
  - IF INMATE CONSENTS, THEY ARE INTERVIEWED BY ICE
- ICE RECEIVES NOTIFICATION OF RELEASE FORM

You will promptly receive a separate letter if the Nevada County Sheriff's office notifies ICE of your release date. 
