RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 1 TO THE CONTRACT WITH GRANITE WELLNESS CENTERS FOR THE PROVISION OF PERINATAL AND NON-PERINATAL OUTPATIENT DRUG FREE TREATMENT AND INTENSIVE OUTPATIENT TREATMENT SERVICES; COMPREHENSIVE RESIDENTIAL TREATMENT PROGRAM SERVICES; AND SUBSTANCE ABUSE PREVENTION AND TREATMENT SERVICES, TO RESIDENTS OF NEVADA COUNTY REVISING EXHIBIT "A" SCHEDULE OF SERVICES AND EXHIBIT "B" SCHEDULE OF CHARGES AND PAYMENTS TO ADD THE PURCHASE OF TWENTY-TWO DEDICATED BEDS AT THE BOST HOUSE RESIDENTIAL TREATMENT FACILITY (RES 23-358)

WHEREAS, On July 11, 2023, per Resolution RES 23-358, the Nevada County Board of Supervisors approved execution of the Professional Services Contract with Granite Wellness Centers as a non-profit organization licensed by the State to provide services for the prevention, treatment and recovery of substance use disorders; and

WHEREAS, Granite Wellness Centers provides Perinatal and Non-Perinatal Outpatient Drug Free (ODF) Treatment Program Services and Intensive Outpatient Treatment (IOT) Services for substance using pregnant and/or parenting women, men and adolescents; Comprehensive Residential Treatment Program Services; and Substance Use Prevention and Treatment Services, to residents of Nevada County; and

WHEREAS, the parties desire to amend their Agreement to revise Exhibit "A" Schedule of Services and Exhibit "B" Schedule of Payments to incorporate the purchase of 22 dedicated beds at the Bost House where the Contractor will provide comprehensive Residential Treatment Program services for adults, including 24 hours/7 days per week supervision and residential services, as well as detox services at Bost House, which is County owned and operated by Granite Wellness Centers.

NOW THEREFORE BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Professional Services Contract by and between the County and Granite Wellness Centers for the provision of Perinatal and Non-Perinatal Outpatient Drug Free Treatment and Intensive Outpatient Treatment Services; Comprehensive Residential Treatment Program Services for substance use disorder treatment; and Substance Use Prevention and Treatment Services to residents of Nevada County, with a maximum contract price remaining at \$3,238,482 for Fiscal Year 2023/24 be and hereby is approved in substantially the form attached hereto and that the Chair be and is hereby authorized to execute this Amendment on behalf of the County.
