



# RESOLUTION No. 26-220

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION APPROVING THE NAMING OF THE CAMPUS LOOP TRAILHEAD PARKING LOT LOCATED AT THE NEVADA COUNTY GOVERNMENT CENTER, 950 MAIDU AVENUE, NEVADA CITY, CALIFORNIA AS “MILE ONE”

WHEREAS, on June 9, 2024, through Resolution 24-412, funds were allocated from the 2024 Revised ARPA Expenditure Plan to a multi-jurisdictional project to develop and implement a wayfinding signage program that strengthens the overall brand of Nevada County and its partners, and promotes sustainable recreation; and

WHEREAS, on December 10, 2024, through Resolution 24-630, the Board of Supervisors authorized the contract between the County of Nevada Community Development Agency and Bear Yuba Land Trust for the design and implementation of the wayfinding signage and communication standards for multi-use pathways, trails, and recreation access points throughout Nevada County in high-use and high-impact recreation areas to promote safety, education, and environmental stewardship; and

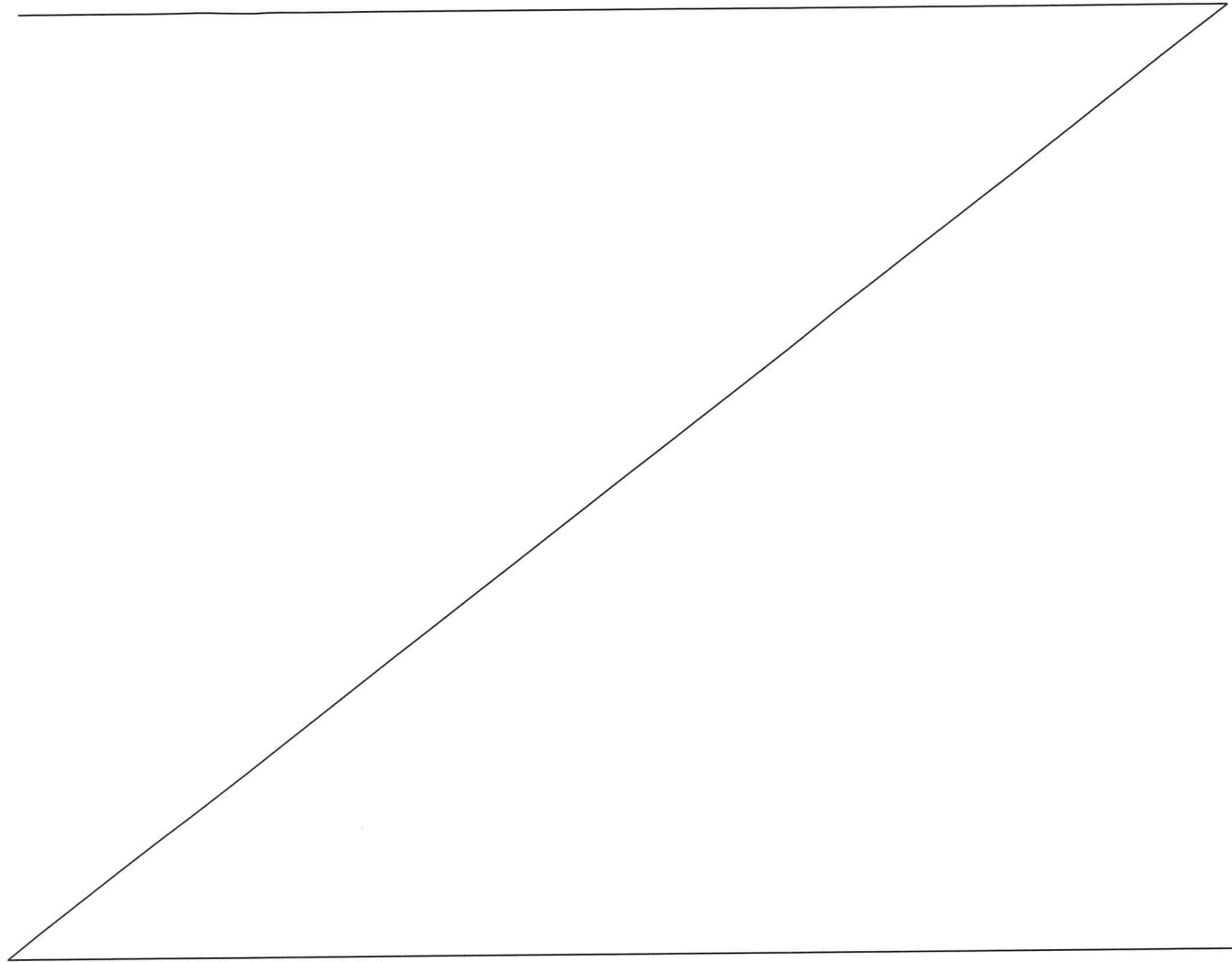
WHEREAS, construction of the campus loop trailhead parking lot began in Fall 2025, and is projected to be completed in Summer 2026, after which a kiosk and associated signage will be installed by Bear Yuba Land Trust pursuant to the wayfinding signage and communication standards contract; and

WHEREAS, the Facilities Department has created an administrative policy to guide naming of County facilities, and in accordance with said policy, the name “Mile One” has been brought to and supported by the Capital Projects Ad Hoc Subcommittee; and

WHEREAS, the name is consistent with policy in that it is not named after a living individual, nor is it offensive or discriminatory, nor does it reflect commercial or corporate identity or sponsorship; and

WHEREAS, “Mile One” reflects the parking lot’s role as the trailhead for the first mile of the Pines to Mines Trail, while also symbolizing the beginning point for many outdoor recreational opportunities throughout Nevada County, with the campus loop trailhead parking lot serving as a central recreation hub.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of County of Nevada, State of California, that the newly constructed campus loop trailhead parking lot located at 950 Maidu Avenue, Nevada City, California shall be named “Mile One”.
