# AMENDMENT #3 TO THE CONTRACT WITH INTEGRATED PSYCHIATRIC SOLUTIONS, INC.

(PESP4362)(Res 22-149)(Res 22-366)

THIS AMENDMENT is executed this 13<sup>th</sup> day of December 2022 by and between INTEGRATED PSYCHIATRIC SOLUTIONS, INC., hereinafter referred to as "Contractor" and COUNTY OF NEVADA, hereinafter referred to as "County." Said Amendment will amend the prior Agreement between the parties entitled Professional Services Contract, executed on September 16, 2021 per Purchase Order No. PESP4362 and amended on April 12, 2022 per Resolution 22-149 and subsequently amended on July 12, 2022 per Resolution 22-366; and

WHEREAS, the Contractor operates services related to mental health; and

**WHEREAS**, there have been unexpected costs for court-ordered mandatory services to ensure the well-being of CWS children; and

**WHEREAS**, the parties desire to amend their Agreement to increase the contract price from \$69,000 to \$75,720 (an increase of \$6,720) and revise Exhibit "B" Schedule of Charges and Payments to reflect the increase in the maximum contract price.

### **NOW, THEREFORE,** the parties hereto agree as follows:

COUNTY OF NEVADA.

- 1. That Amendment #3 shall be effective as of July 1, 2021.
- 2. That Maximum Contract Price, shall be amended to the following: \$75,720.
- 3. That the Schedule of Charges and Payments, Exhibit "B" is amended to the revised Exhibit "B" attached hereto and incorporated herein.
- 4. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.

#### **CONTINGENCY**

Contract maximum is contingent and dependent upon the County's annual receipt of anticipated State/Federal Funds for contract services.

#### **BILLING AND PAYMENT**

Contractor shall submit an invoice to County by the 20<sup>th</sup> of each month following the month services were rendered. Each invoice shall include:

- Dates/Month/hours of services rendered
- Cost of services rendered identifying total direct costs
- Billing period covered
- Contract Number assigned to the approved contract
- Unique invoice number for each invoice submitted
- Supporting documentation

County shall review each billing for supporting documentation, dates of services, and costs of services as detailed previously. Should there be a discrepancy on the invoice, said invoice will be returned to Contractor for correction and/or additional supporting documentation. Payments will be made in accordance with County processes once an invoice has been approved by the Department.

#### **BILLING AND PAYMENT EXCEPTION**

By the tenth of June each year, Contractor shall provide an invoice for services rendered for the month of May. An invoice of services provided for the month of June shall be provided no later than the tenth of July.
