SUBJECT: Resolution approving Amendment No. 2 to the contract with Common Purpose for the provision of recovery residence services for Nevada County Medi-Cal beneficiaries to increase the maximum contract price from \$194,400 to \$204,400 (an increase of \$10,000), and revise Exhibit "B", Schedule of Charges and Payments to reflect the increase in the maximum contract price.(RES 22-300, RES 23-126)

RECOMMENDATION: Approve the attached Resolution.

FUNDING: Funding is provided with SABG (Substance Abuse Block Grant) monies and 2011 Realignment. There are no county general fund dollars required in the Agreement.

BACKGROUND: On June 28, 2022, per Resolution 22-300, the Nevada County Board of Supervisors approved execution of the Professional Services Contract with Common Purpose to provide education and treatment services to persons affected by substance use disorders, which was subsequently amended on March 28, 2023 per Resolution 23-126.

The treatment programs provided by Common Purpose are designed to help individuals and families achieve and maintain healthy and rewarding lives leading to long-term self-sufficiency and the restoration of family systems. Recovery Residences services are for male and female adults (over the age of 18) and their children as authorized by the County Behavioral Health Department. Recovery Residences provide an affordable clean and sober supported living environment where individuals can rebuild their own housing and employment resources while still participating in a lower level of care. There has been growing need for more recovery residence services.

This amendment is coming to the board in July as the uptick in people going to Recovery

Residences with Common Purpose started in April (billed to us in May) and went up again in May (billed to us in June) and we are projecting it to be the same in June. It is recommended that the Board approve this Amendment as the services provided will help program participants achieve and maintain healthy and stable lives, leading to long-term self-sufficiency and the restoration of family systems.
