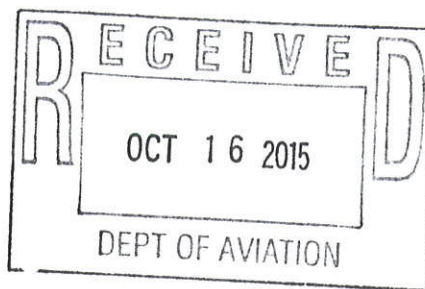

We are pleased to inform you that, acting on the authority of the California Transportation Commission, with the approval of the California Department of Transportation (Caltrans), \$7,874 in State Aeronautics funds have been allocated to the County of Nevada. These funds are intended as a portion of the match for your Federal Aviation Administration (FAA) Airport Improvement Program (AIP) Grant No. 3-06-0095 -017-2015 at the Nevada County Airport. ALLOCATION OF STATE FUNDS TO MATCH
FEDERAL AIRPORT IMPROVEMENT PROGRAM GRANTS

Pursuant to Section 21683.1 of the Public Utilities Code (PUC), the California Transportation Commission (CTC) is authorized to allocate funds for a portion of the local match for Federal Airport Improvement Program (AIP) grants to certain airports.

By **Resolution FDOA-2014-10 on June 25, 2015**, the CTC resolved that, as regards Federal Airport Improvement Program Grants made by the Federal Aviation Administration to public entities in this state from July 1, 2015 through June 30, 2016, with the approval of the Department of Transportation, at such time as the federal grant offer is accepted by the public entity applicant, there is allocated to each applicant from the Aeronautics Account five percent (5%) of that portion of the grant whose primary benefit is for general aviation in order to provide a part of the local match for the grant in accordance with the provisions of Public Utilities Code section 21683.1, until the total of such allocations equals \$1,000,000.

State Matching Grant Number: Nev-3-15-1-Mat

On **October 5, 2015** in accordance with authority granted by the CTC, with the approval of the Department, the sum of **\$7,874** has been allocated to the **County of Nevada** for State AIP match to the **Nevada County** Airport.
