BACKGROUND:

Currently, there are four positions available on the Agricultural Advisory Commission. One Livestock Other Than Cattle and Equine Industry Representative and one Equine Industry Representative position for a 4-year terms ending March 31, 2026. One Farming Industry Representative position becoming available April 1, 2022, for a 4-year term ending March 31, 2026. One Cattle Industry Representative position becoming available April 1, 2022, for a 4-year term ending March 31, 2026. These vacancies and position were advertised and posted for a minimum of ten days at the following places: The Board of Supervisors Chambers Bulletin Board, the Board of Supervisors office, and the County website. Notice was also posted at the Truckee Town Hall, and the District V Board of Supervisors office in Truckee.

Alyssa Mayo submitted an application on February 14, 2022 for reappointment as the Equine Industry member, Alyssa was first appointed to this position April 13, 2021. Brad Fowler submitted an application on February 17, 2022 for reappointment as the Livestock Other Than Cattle and Equine Industry Representative, Brad was first appointed to this position April 9, 2013. Both members are in good standing and were recommended for reappointment by Commissioner Chris de Nijs.

Please consider approving the reappointment of Alyssa Mayo as Equine Industry Representative and Brad Fowler as Livestock Other Than Cattle and Equine Industry Representative to the Agricultural Advisory Commission for four-year terms ending March 31, 2026.
