



# RESOLUTION No. 22-347

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION AMENDING RESOLUTION 11-520 PERTAINING TO PARKING VIOLATION PENALTIES OF VARIOUS LOCATIONS FOR REASONS OF PUBLIC SAFETY

WHEREAS, pursuant to Vehicle Code § 40203.5, the Board of Supervisors shall establish the schedule of parking penalties which shall be collected as civil penalties; and

WHEREAS, the Nevada County Board of Supervisors adopted Resolution 11-520 on November 8, 2011, which amended Resolution 95-96 adopted on March 21, 1995 amending Resolution 94-53 adopted on February 15, 1994, whereby a Schedule of Penalties for parking and parking-related equipment and registration violations was adopted as Exhibit "A" and administrative charges were established; and

WHEREAS, on June 12, 2018 the Board of Supervisors adopted Resolution 18-238 amending Resolution 11-520 adding Purdon Crossing and Edwards Crossing Parking Penalty Schedule to the Schedule of Penalties for parking and parking-related equipment and registration violations adopted as Exhibit "A"; and

WHEREAS, members of the public park in "No Parking" zones in various locations throughout the County that create public safety issues, including blocking the road for emergency vehicles, and the public walking on the road from their illegally parked vehicles to access recreational areas, in addition to the negative impact to the environment; and

WHEREAS, law enforcement, fire authorities, recreational agencies and stakeholder coalitions that include the Yuba River Public Safety Cohort and The CCC (Catalyst, Convene, and Champion) recommend increased illegal parking violation penalties for purposes of public safety at Bunny Hill Road and Castle Peak off-ramp from I-80, Donner Lake Interchange off-ramp from I-80 near Johnson Canyon, Coyote Street from North Bloomfield-Graniteville Road 0.528 miles south to the Nevada City Limit, Dog Bar Road from the bridge crossing Bear River to Magnolia Road, Donner Pass Road from the Interstate 80 West off-ramp to the town limit of the Town of Truckee, Maybert Road from Washington Road 2.93 miles east to the Canyon Creek Bridge, Newtown Road from State Highway 49 to 500 feet southwest on Newtown Road, Old Downieville Highway from Cedro Road to the Nevada City limit and Champion Road from Newtown Road to Old Downieville Highway, Pleasant Valley Road from 2,500 feet south of the Yuba River Bridge on Pleasant Valley Road at the South Yuba State Park to 1,500 feet north of the Yuba River Bridge on Pleasant Valley Road at the South Yuba State Park, Relief Hill Road from Gaston Road 0.466 miles west to the end of pavement, Soda Springs Road from Donner Pass Road thence southerly to the Nevada-Placer County boundary, Via Vista between Ridge Road and 200 feet east of its intersection with Echo Ridge Drive, and Washington Road from Maybert Road to 1,500 feet west of the South Yuba River Bridge on Washington Road; and

WHEREAS, the Nevada County Board of Supervisors desires to provide public safety to visitors, protect the environment and provide first responders the ability to quickly and safely access and respond to emergencies as needed; and

WHEREAS, to discourage parking in "No Parking" zones, the Nevada County Board of Supervisors establishes penalties for the above identified and recommended locations as identified in the attached Exhibit A Schedule A.2, which includes the previously adopted administrative fees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that:

1. The fines to be collected for the processing of all parking violations at Bunny Hill Road and Castle Peak off-ramp from I-80, Donner Lake Interchange off-ramp from I-80 near Johnson Canyon, Coyote Street from North Bloomfield-Graniteville Road 0.528 miles south to the Nevada City Limit, Dog Bar Road from the bridge crossing Bear River to Magnolia Road, Donner Pass Road from the Interstate 80 West off-ramp to the town limit of the Town of Truckee, Maybert Road from Washington Road 2.93 miles west to the Canyon Creek Bridge, Newtown Road from State Highway 49 to 500 feet southwest on Newtown Road, Old Downieville Highway from Cedro Road to the Nevada City limit and Champion Road from Newtown Road to Old Downieville Highway, Pleasant Valley Road from 2,500 feet south of the Yuba River Bridge on Pleasant Valley Road at the South Yuba State Park to 1,500 feet north of the Yuba River Bridge on Pleasant Valley Road at the South Yuba State Park, Relief Hill Road from Gaston Road 0.466 miles east to the end of pavement, Soda Springs Road from Donner Pass Road thence southerly to the Nevada-Placer County boundary, Via Vista between Ridge Road and 200 feet east of its intersection with Echo Ridge Drive, and Washington Road from Maybert Road to 1,500 feet west of the South Yuba River Bridge on Washington Road, as identified in Exhibit A are hereby adopted.
2. The locations of fines to be collected for the processing of all parking violations at Edwards Crossing and Purdon Crossing as identified in Exhibit A are hereby further clarified for reasons to prevent site ambiguity.


