## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION TO APPROVE THE COLLECTION OF PARCEL CHARGES AND SPECIAL TAXES FOR SERVICES IN COUNTY SERVICE AREAS AND PERMANENT ROAD DIVISIONS FOR FISCAL YEAR 2023/24

WHEREAS, the Director of the Department of Public Works has prepared the Parcel Charges and Special Taxes in County Service Areas and Permanent Road Divisions (CSA and PRD); and

WHEREAS, the Parcel Charges and Special Taxes are in conformance with Proposition 218, as approved by the voters in November 1996.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors authorizes the collection of parcel charges and special taxes for Fiscal Year 2023/24 in the CSAs and PRDs as follows:

Road Maintenance Services are subject to 5.0% annual inflationary adjustment for all parcels, regardless of improved status, beginning in Fiscal Year 2024/25, continuing twenty (20) years, ending with the final FY 2044/45. A fixed, 3-year catch up of emergency service funds in the amount of \$333.32 for Fiscal Year 2023/24, \$333.32 for Fiscal Year 2024/25, and \$333.36 for Fiscal Year 2025/26 will be charged in addition to the Road Maintenance Services to each parcel, regardless of improvement status.

The Parcel Charge shall be adjusted annually based on the Consumer Price Index, as set forth in the San Francisco/Oakland/San Jose Metropolitan Area Consumer Price Index for all Urban Customers as of January 1st each calendar year (posted as December month ending data), not to exceed five percent (5%) in any one year.

Snow removal is levied annually at the rate of \$275.00 per unimproved parcel and \$820.00 per improved parcel per fiscal year, beginning in FY 2020/21, and continuing indefinitely for each fiscal year thereafter, with annual adjustments beginning in FY 2021/22 as set forth in the *San Francisco Area Consumer Price Index, as of January 1<sup>st</sup>* (posted as December month ending data) of each calendar year, not to exceed 5% per year.

Authorizes an annual adjustment to the road maintenance charges beginning in FY 2020/21 and continuing indefinitely for each fiscal year thereafter as set forth in the *San Francisco Area Consumer Price Index, as of January 1<sup>st</sup>* (posted as December month ending data) of each calendar year, not to exceed 5% per year.

AND BE IT FURTHER RESOLVED that the Nevada County Board of Supervisors authorizes the Auditor/Controller to collect fees and charges in regard to the administration of these charges in accordance with Resolution No. 15-278.
