To the Board of Supervisors, especially my supervisor Dan Miller,



**Dear Supervisors Miller, Hall, Hoek, Scofield, and Bullock, -**

**It is with great concern that I write this email. It greatly saddens me that the country and our county is facing a great divide - as well as possible local insurrections & domestic terrorism acts. Some people are turning to violence instead of balanced discussions of our differences as adults. The lies and the misinformation that these domestic terrorists are believing and spewing are very disturbing.**

**Like me, I'm sure you are in shock after last week's assault on the Capitol. I am writing to you to share a credible violent threat made against our local Board of Supervisors, City, and Public Health officials by the Freedom Angels. It is important you take these veiled threats seriously as their rhetoric has escalated and is empowered by the tragic events of last week. The Board of Supervisors and our Pubic Health Officer are their #1 targets locally.**

**As a reminder of the "Reopen / Health Freedom" local actions in 2020, please see a video of Tara Thornton of Truckee, CA, and the "ReOpen"**

members attempting to force their way into the Rood Center in August.

Tara Thornton and Denise Aguilar-Mendez of Stockton, CA, appeared on the “Health Freedom” stage at the Stop the Steal protest in Washington, DC. They then proceeded to storm the Capitol building and participated in the insurrection. Please see video of their stage presentation, where they call for people to go to the Governor, County Supervisors, and public health official’s homes to ‘destroy the system’, because they are ‘done’. Freedom Angels now have an insurrection training camp in Stockton, training women in ‘offensive weapons use’, calling themselves the “Mom Militia”. While saying they are ‘peaceful’, they are planning their role in the civil war. Please see a video of Denise reporting after ‘storming the Capitol’ with Tara and getting tear-gassed. Tara Thornton and Denise Aguilar have escalated their rhetoric and say “we are beyond talking to our electeds” and ‘it’s gone time’. They have a Nevada County cell, and we know of at least three other Nevada County residents who attended the insurrection in DC.

I am imploring you to increase your personal security for the next 30 days, especially Supervisor Hall and Dr. Kellermann.

I am also imploring you to make a unified public statement, as our community leadership, to denounce the violent insurrection in Washington, DC, and to endorse the legitimate election results as free and fair. This is not political. These unfortunate folks have been radicalized with misinformation & proven downright lies for years. It's so hard to believe it has gotten this far. This is a call for basic human decency and peace.

We must have a strong and immediate public response to their illegal actions. Those who are misinformed and misguided about the election results and “health freedom” will be further empowered toward violence. That violence will be directed towards you and maybe other citizens that don't agree with the 'violent' domestic terrorists. Don't kid yourselves, these people believe violence is the only way.

Please be ready to protect our citizens and property. Thank you for your attention to this urgent matter and your service to our community during this unprecedented time in our history.
