## RESOLUTION NO. SD 16-001 OF THE BOARD OF DIRECTORS OF NEVADA COUNTY SANITATION DISTRICT NO. 1

RESOLUTION DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE FISCAL YEAR 2015/16 BUDGET FOR THE SANITATION DISTRICT NO. 1, PENN VALLEY (ZONE 6) CAPITAL IMPROVEMENT PROJECT FUND (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the County of Nevada's Health and Human Services Agency/Housing and Community Services Division was successful in a \$2,000,000 application to the State Housing and Community Development (HCD) Community Development Block Grant (CDBG) Program; and

WHEREAS, in funding this award (#13-CDBG-8931), the State HCD CDBG Program will provide the County of Nevada Housing and Community Services Division (HCS) \$1,953,750 which includes implementation of the Penn Valley Sewer District System Improvements - installation of 4.5 miles of sewer main lines from Penn Valley to the Lake Wildwood Wastewater Treatment Facility to mitigate health and safety issues, to benefit approximately 404 low-moderate income persons in the amount of \$1,302,326 (Resolution 14-041); and

WHEREAS, these funds will now be expended from the Penn Valley Capital Improvement Project needs in Fiscal Years 2015/16; and

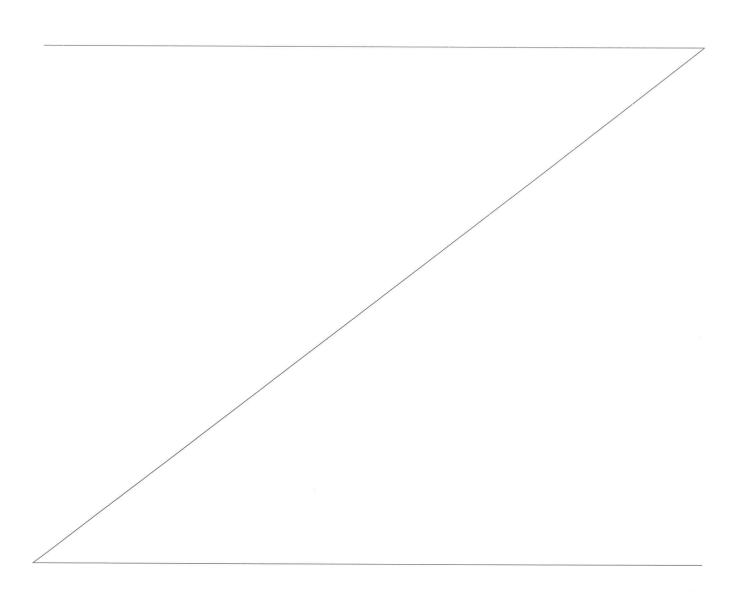
WHEREAS, the department needs to amend the Fiscal Year 2015/16 budget to provide for receipt of revenue from HCS and related construction expenditures related to the Penn Valley Improvement Project.
