**SUBJECT:** Resolution to award the contract for the Combie Road Multi-Use Path Project to Hansen Bros Enterprises for a total amount of \$1,114,941.30 under County Project Number 440844 – District II

**RECOMMENDATION:** Approve the attached resolution.

**FUNDING:** There is no impact to the General Fund. The project is budgeted in FY 24/25 Road Capital Improvements, funded by Congestion Mitigation and Air Quality Program federal grant funds.

**BACKGROUND:** On February 11, 2025, the Nevada County Board of Supervisors approved Resolution 25-047 to authorize the Purchasing Agent to solicit bids for the Combie Road Multi-Use Path Project.

The bids for the project were opened on March 20, 2025, and are listed below:

This project is funded by a federal program and therefore has a Disadvantage Business Enterprise (DBE) utilization goal of 22.64%. On any project with a DBE goal, if the contractor does not meet or exceed the utilization goal, a Good Faith Effort (GFE) is required to be completed showing that DBE participation on the project was solicited. The low bidder, Hansen Bros Enterprises, submitted a GFE that was evaluated and determined to be valid.

It is recommended that the contract be awarded to the low bidder, Hansen Bros Enterprises at the bid price of \$1,013,583.00, plus a 10% contingency of \$101,358.30 for a total of \$1,114,941.30. Work is expected to begin in May 2025.
