**RECOMMENDATION:** Ratify the reappointment of Ms. Dena Valin-Malakian as a Low-Income Sector representative; and the appointment of Ms. Jennifer Morrill as a Low-Income Sector representative, to fill the position previously held by Ms. Nancy Baglietto who has not requested to continue her term, both to the Adult and Family Services Commission (commission) for two-year terms ending April 30, 2021.

**BACKGROUND:**

Currently there are 4 vacancies and 3 positions on the Adult and Family Services Commission; One Public Sector position available April 30, 2019 for a 2-year term ending April 30, 2021; Two Low-Income Sector positions available April 30, 2019 for 2-year terms ending April 30, 2021; and Four Private Sector vacancies; two to fill 2-year unexpired terms ending April 30, 2019, and two to fill 2-year unexpired terms ending April 30, 2020. These positions were advertised and posted for a minimum of ten days at the following places: Board of Supervisors Chambers Bulletin Board, Board of Supervisors Office, Madelyn Helling Library, and on the "MyNevadaCounty" website. Notice was also posted at Grass Valley Library, Truckee Library, Truckee Joseph Center, the Truckee Town Hall, and the District V Board of Supervisors office in Truckee.

Ms. Dena Valin-Malakian, who has served on the commission since April 26, 2011, submitted an application to be reappointed, and Ms. Jennifer Morrill submitted an application to be appointed. The Commission accepted both the reappointment and the appointment at their meeting of April 9, 2019 and provided their recommendation for Ms. Valin-Malakian and Ms. Morrill.

Please ratify the reappointment of Ms. Dena Valin-Malakian as a Low-Income Sector representative; and the appointment of Ms. Jennifer Morrill as a Low-Income Sector representative, to the Adult and Family Services Commission for two-year terms ending April 30, 2021.
