RESOLUTION FOR THE NOTICE OF ACCEPTANCE AND COMPLETION FOR THE DONNER PASS ROAD ROCKSLIDE PROJECT – COUNTY PROJECT NO. 700300 AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE FISCAL YEAR 2023/24 BUDGET (4/5 AFFIRMATIVE VOTE REQUIRED) – DISTRICT V

WHEREAS, the County of Nevada entered into an agreement with Neil's Controlled Blasting, L.P. by Resolution 23-441 for a contract totaling \$389,695.00 plus a 10% contingency of \$38,969.50 for the contract work items, for a total of \$428,664.50; and

WHEREAS, said contract for the Donner Pass Road Rockslide Project (Project) was completed in accordance with the contract; and

WHEREAS, the Project improvements were completed to the satisfaction of the Nevada County Department of Public Works on August 23, 2023, with contract costs totaling \$237,244.50; and

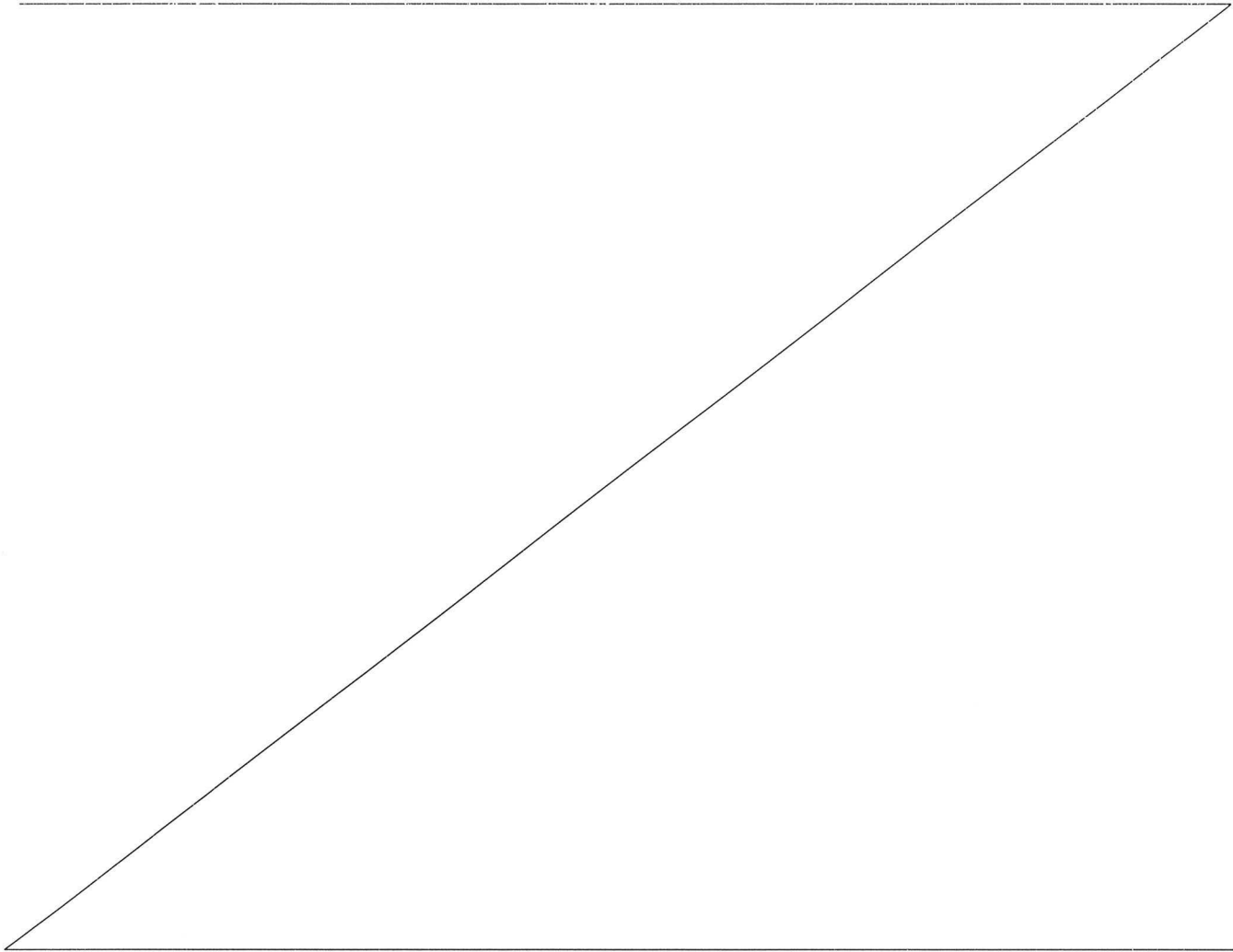
WHEREAS, the total project costs were \$475,011.00 including the blasting contract, geotechnical engineering consultants, Roads Engineering and Maintenance crew labor and equipment; and

WHEREAS, Resolution 23-441 approved a request for General Fund reimbursement for these unanticipated project costs and a budget amendment is required to transfer the funds from unassigned General Fund balances to Public Works Roads Engineering and Maintenance.

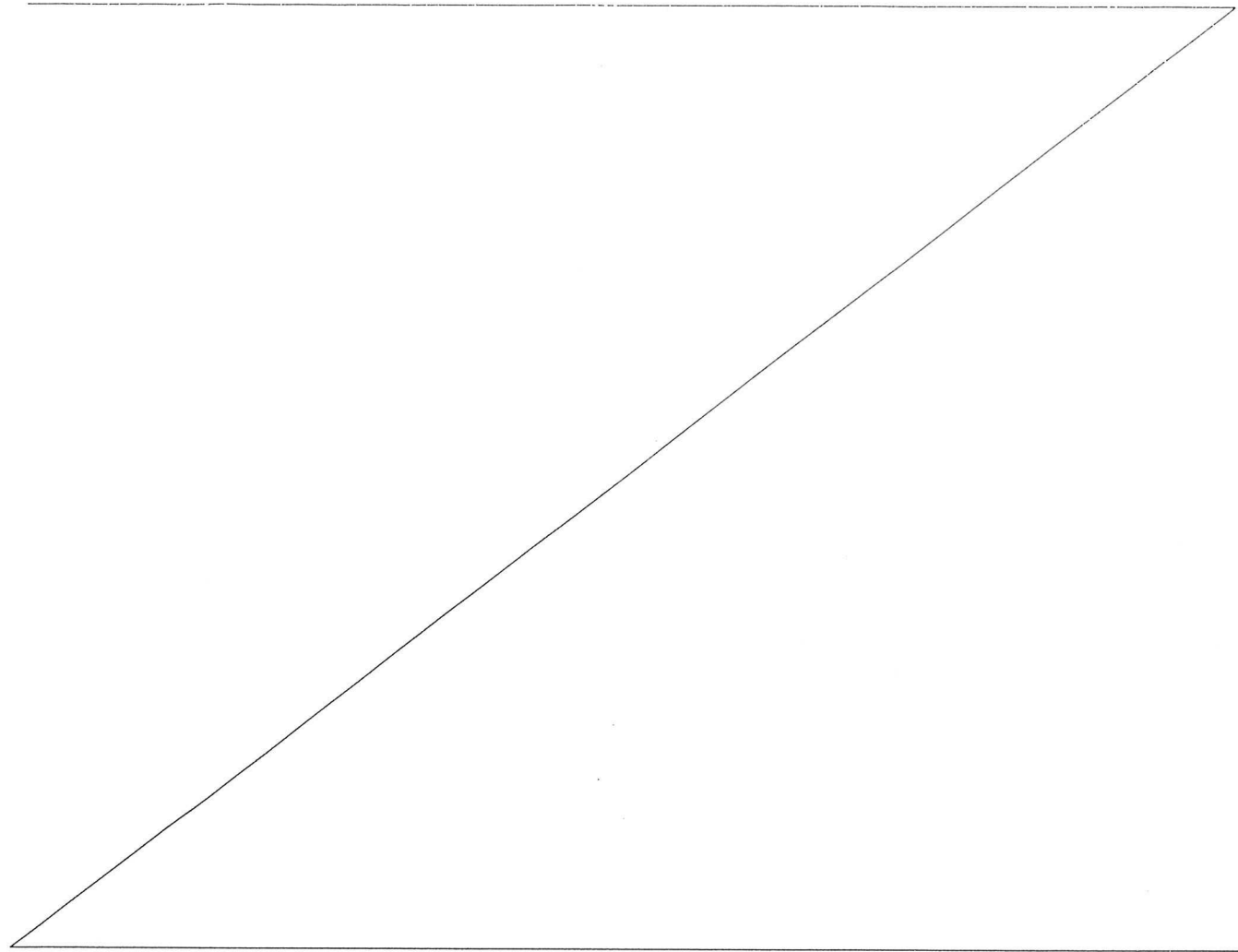


