



# RESOLUTION No. 26-206

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION APPROVING EXECUTION OF A RENEWAL CONTRACT WITH FOOTHILL HOUSE OF HOSPITALITY, DBA HOSPITALITY HOUSE, FOR THE PROVISION OF HOMELESS OUTREACH, ACCESS, LINKAGE TO TREATMENT SERVICES, AND TRANSITIONAL HOUSING SERVICES THROUGH THE BEHAVIORAL HEALTH BRIDGE HOUSING PROGRAM IN THE MAXIMUM AMOUNT OF \$1,100,197, FOR THE TERM OF JULY 1, 2026, THROUGH JUNE 30, 2027

WHEREAS, Hospitality House is a local non-profit organization that provides emergency shelter and supportive services to Nevada County's homeless population; and

WHEREAS, Projects for Assistance in Transition from Homelessness (PATH) is designed to provide services to individuals who have a severe mental illness, or who have co-occurring severe mental illness and substance use disorders, and who are homeless or at imminent risk of becoming homeless; and

WHEREAS, the Department of Health Care Services has made available Behavioral Health Bridge Housing funds through a grant award to Nevada County to implement an interim non-congregate housing program; and

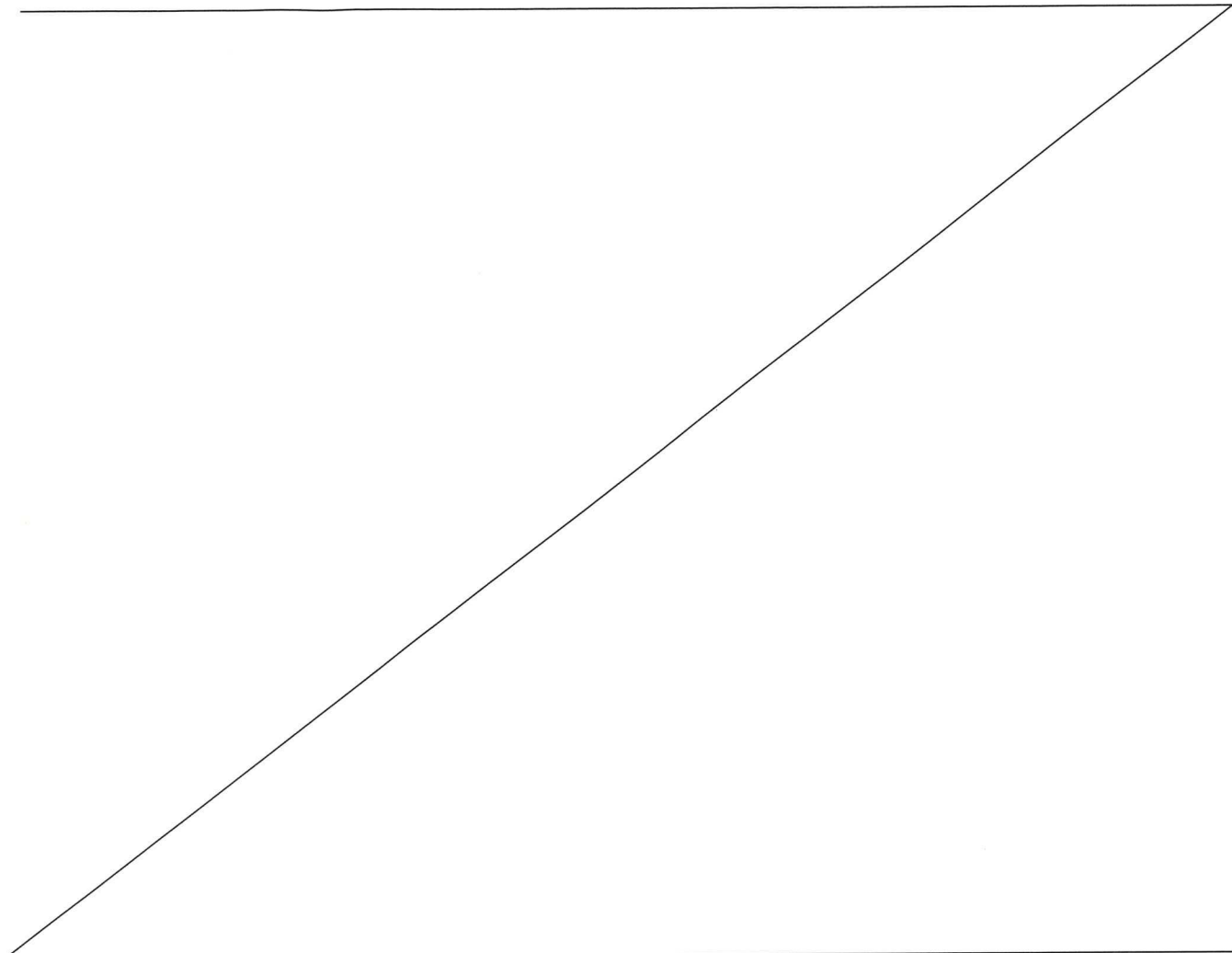
WHEREAS, Behavioral Health Services Act funds have been allocated to provide outreach, engagement, and linkages to services for individuals experiencing unsheltered homelessness through street outreach; and

WHEREAS, these services promote resiliency and recovery from substance use disorder, access to behavioral health services, and linkage to ongoing stabilizing services for a vulnerable population of Nevada County.

NOW THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Professional Services Contract by and between the County of Nevada and Foothill House of Hospitality, DBA Hospitality House, pertaining to the provision of housing options and supportive services for individuals experiencing homelessness in the maximum amount of \$1,100,197, for the term of July 1, 2026, through June 30, 2027, be and hereby is approved in substantially the form attached hereto, and the Chair of the Board of Supervisors is authorized to execute the Contract on behalf of the County of Nevada. This contract is contingent upon the adoption of the Fiscal Year 2026/27 County Budget. The contract begins on July 1, 2026.
