



# **RESOLUTION No. 25-481**

## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

### **RESOLUTION AMENDING RESOLUTION 24-328 TO REDISTRIBUTE FUNDING ALLOCATIONS**

WHEREAS, the County of Nevada entered into a three year Contract for Professional Services for blood draws, maintenance of breath testing instruments and expert testimony in the course of prosecutions; and

WHEREAS, the County of Nevada receives funding from the Nevada County Superior Court pursuant to Penal Code section 1463.14 from driving under the influence (DUI) fines and fees that are deposited into a special fund (1369) to be used exclusively to pay for toxicology services; and

WHEREAS, the funding received into this special fund has not been sufficient to cover the costs of the monthly invoices from Valley Toxicology Services, Inc., and, when Penal Code section 1463.14 funds are exhausted, the remaining costs for services are paid from the general fund; and

WHEREAS, the District Attorney's Office is requesting to amend Resolution 24-328 to revise the funding allocations by decreasing the amount paid from the 1369 fund and increasing the amount paid from the General Fund; and

WHEREAS this reallocation will not change the total contract amount or any other terms of the agreement with Valley Toxicology Services.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Nevada hereby authorizes the amendment to Resolution 24-328 to redistribute the funding sources for the District Attorney's portion of the contract with Valley Toxicology Services, Inc., as follows:
