WHEREAS, the County of Nevada entered into Contract No. 450006 with Sierra Nevada Construction, Inc. on April 14, 2020, by Resolution 20-117 for a contract totaling \$ 844,007.00 plus a 10% contingency of \$84,440.70 for the contract work items, and amended/increased the contract on June 23, 2020, in the amount of \$100,000 by Resolution 20-260 for a maximum not to exceed amount of \$1,028,407.70; and

WHEREAS, said Contract was for the 2020 Road Rehabilitation Project and was constructed in accordance with the plans and specifications; and

WHEREAS, the Improvements were completed to the satisfaction of the Nevada County Department of Public Works on July 24, 2020, with contract costs totaling \$928,434.14
