SUBJECT: Resolution approving Amendment 1 to the Agreement for Services #8848 between the County of Nevada and the County of El Dorado for the provision of Telephone Triage Services for El Dorado County Adult System of Care and Children's System of Care to amend services in Articles I, II, III, IV; to increase the maximum revenue amount from \$50,748 to \$182,790, for the initial of period July 1, 2023 through June 30, 2026; to increase the maximum amount not to exceed amount by \$417,210 for the optional 3 year extension, and authorize the Nevada County Director of Behavioral Health to execute the amendment.

RECOMMENDATION: Approve the attached Resolution.

FUNDING: This is a revenue agreement whereby El Dorado County pays Nevada County Behavioral Health Department a quarterly rate as full payment for each full month during which Telephone Triage Services are provided. There are no county general funds required.

BACKGROUND: On June 25, 2024, per Resolution 24-306, the Nevada County Board of Supervisors approved execution of the Agreement for Services # 8848 with County of El Dorado for the provision of Telephone Triage Services for El Dorado County Adult System of Care and Children's System of Care. Under this agreement, Nevada County, through a contract with Auburn Counseling Services, Inc., is agreeing to provide Telephone Triage Services for the El Dorado County after-hours crisis line.

This amendment serves to change the scope of work to include operation of the County Crisis Line and the County Access Line twenty-four (24) hours per day, seven (7) days per week including weekends and County holidays. Scope has also been amended to include dispatch of the Mobile Crisis Team. It also increases the revenue maximum in the initial term as well as in the optional extension term.

It is respectfully recommended that the Board of Supervisors approve this agreement, which serves to strengthen and promote the mutual working relationship between El Dorado and Nevada Counties.
