### **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

**RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 2 TO THE PERSONAL SERVICES CONTRACT WITH AUBURN COUNSELING SERVICES, INC., D/B/A COMMUNICARE TO INCREASE THE MAXIMUM CONTRACT AMOUNT TO \$1,238,144 (AN INCREASE OF \$40,078), REVISING EXHIBIT "A" TO ADD AN ADDITIONAL .75 FTE CARE COORDINATOR POSITION AND REVISING EXHIBIT "B" SCHEDULE OF CHARGES AND PAYMENTS TO REFLECT THE INCREASE IN THE MAXIMUM CONTRACT PRICE (RES. 19-306; RES. 19-560)**

WHEREAS, per Resolution 19-306, the Nevada County Board of Supervisors approved the renewal contract with Auburn Counseling Services, Inc. dba Communicare to provide Phone Triage Services for the Nevada County Behavioral Health Department; Regional Telephone Triage Services for Placer County's Adult System of Care and Children's System of Care (CSOC); substance use disorder counseling; mental health therapy in the jail; New Directions Program Services, as well as Patients' Rights and Quality Assurance Services, and as First Amended on October 22, 2019; per Resolution 19-560, to add services for Plumas and Sierra Counties; and

WHEREAS, the parties desire to amend their agreement to 1) increase the Maximum Contract Price from \$1,198,066 to \$1,238,144 (an increase of \$40,078); 2) revise Exhibit "A" Schedule of Services to an additional .75 FTE Personal Services Coordinator, and 3) revise Exhibit "B" Schedule of Charges and Payments to reflect the increase in the maximum contract price.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 2 to the Personal Services Contract by and between the County of Nevada and Auburn Counseling Services, Inc., dba Communicare pertaining to the provision of Phone Triage Services for the Nevada County Behavioral Health Department; Regional Telephone Triage Services for Placer County's Adult System of Care and Placer County's Children's System of Care (CSOC), Substance Use Disorder Counseling; Mental Health Therapy in the jail; New Directions Program Services, as well as Patients' Rights and Quality Assurance Services pertaining to the maximum contract price of \$1,238,144 for Fiscal Year 2019/20 be and hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.
