OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION RESCINDING RESOLUTION 24-163 AND APPROVING A REVISED AMENDMENT TO THE AGREEMENT WITH PARTNERSHIP HEALTHPLAN OF CALIFORNIA (RES. 23-572) TO REPLACE ATTACHMENTS B AND D TO ADD IN MISSING BILLING INFORMATION AND PUBLIC HEALTH CLINIC MEDICAL SPECIALTIES UNDER THE CURRENT EVERGREEN AGREEMENT FOR THE TERM COMMENCING JANUARY 1, 2024, AND IN EFFECT UNTIL TERMINATED

WHEREAS, Partnership HealthPlan of California (PHC) contracts with the California Department of Health Care Services (DHCS) to provide Medi-Cal benefits to eligible persons; and

WHEREAS, on December 5, 2023, Resolution 23-572 approved execution of an agreement with PHC for reimbursement of covered public health clinical services provided to members and for coordination of services with the agreement term commencing January 1, 2024 and remaining in effect until terminated; and

WHEREAS, on April 23, 2024, pursuant to Resolution 24-163, the Board of Supervisors approved the Amendment to include missing critical billing information including Nevada County Public Health's service addresses, Billing National Provider Identification (NPI), Tax Identification Number, and medical specialties but prior to full ratification of the Amendment, PHC notified Public Health that the amendment did not match the most current template language approved by the Department of Health Care Services; and

WHEREAS, the parties desire to amend their Agreement to replace Attachments B and D to add in missing billing information and Public Health Clinic medical specialties; and

WHEREAS, this agreement with Partnership and Nevada County Public Health to reimburse the Public Health department for services provided to Medi-Cal clients seeking care for TB, immunizations and reproductive health services is not part of the current negotiations with other health care providers in the County who are negotiating with Partnership for contractual services to serve Medi-Cal clients in the County.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Resolution 24-163, dated April 23, 2024, approving the initial Amendment No. 1 to the Healthcare Services Agreement between Partnership Health Plan of California to include missing critical billing information including Public Health's service addresses, Billing National Provider Identification (NPI), Tax Identification Number, and medical specialties, is hereby rescinded.

BE IT FURTHER RESOLVED by the Board of Supervisors of the County of Nevada, State of California, rescinds Resolution 24-163 and approves the Ancillary Amendment 1 to the Agreement with the Partnership HealthPlan of California for reimbursement of covered services at the established rate(s) provided to members and for coordination of services with the Agreement term commencing January 1, 2024, and remaining in effect until terminated be and hereby is approved, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.
