OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING THE EXECUTION OF AMENDMENT NO. 1 TO THE PARTICIPATION AGREEMENT WITH THE CALIFORNIA MENTAL HEALTH SERVICES AUTHORITY CONNEX PROGRAM TO REVISE EXHIBIT "A", PROGRAM DESCRIPTION TO REFLECT THE ADDITION OF A SUBSCRIPTION FOR THE CALMHSA CONNEX ADMISSION, DISCHARGE, TRANSFER ("ADT") DASHBOARD AT NO ADDITIONAL COST TO PARTICIPANT BEGINNING JANUARY 1, 2026, AND EXISTING UNTIL THE END OF THE CONTRACT TERM IN THE MAXIMUM AMOUNT OF \$222,948 (RES. 24-098)

WHEREAS, the State and Center for Medicare and Medicaid Services (CMS) have published various interoperability and patient access requirements that providers must follow; and

WHEREAS, the Nevada County Behavioral Health Department entered into a contract with the California Mental Health Services Authority (CalMHSA) Semi-Statewide Electronic Health Record Program for the services related to a California-centric Electronic Health Record (EHR); and

WHEREAS, CalMHSA is a Joint Power Authority representing County Behavioral Health Departments under the authority of the Government Code; and

WHEREAS, CalMHSA designed "CalMHSA Connex", a managed Interoperability Software as a Service (SaaS) solution (the "Services"); and

WHEREAS, on March 12, 2024, per Resolution 24-098, the Nevada County Board of Supervisors authorized the execution of the Agreement between the County of Nevada and CalMHSA for the CalMHSA Connex Program to meet federal and state interoperability requirements; and

WHEREAS, Admission, Discharge, Transfer ("ADT") information can reveal crucial health information such as emergency department visits to improve client care coordination; and

WHEREAS, the parties desire to amend their Agreement to revise Exhibit "A", Program Description and Funding to include a subscription for the CalMHSA Connex ADT Dashboard at no additional cost to Participant beginning January 1, 2026, and existing until the end of the contract term.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Amendment No.1 to the Participation Agreement by and between the CalMHSA, pertaining to the addition of an ADT dashboard within the CalMHSA Connex managed Interoperability SaaS solution for the contract term of January 1, 2024, through December 31, 2026, in the maximum contract amount of \$222,948, be and hereby is approved, and that the Chair of the Board of Supervisors, is authorized to execute the Amendment on behalf of the County of Nevada.
