RECOMMENDATION: Approve the attached resolution.

BACKGROUND: Since Federal Fiscal Year 1995, the Federal Transit Administration (FTA) has been consolidating the various certifications and assurances that may be required of its applicants and their projects into a single document for publication in the Federal Register. The FTA intends to continue publishing this document annually, often in conjunction with its publication of the FTA annual apportionment notice, which sets forth the allocations of funds made available by the latest U.S. Department of Transportation Annual Appropriations Act.

In accordance with 49 U.S.C. 5323(n), certifications and assurances have been compiled for FTA assistance programs. FTA requests each applicant to provide as many certifications and assurances as needed for all programs for which the applicant intends to seek FTA assistance during Federal Fiscal Year 2025. The attached list provides the applicable Federal Fiscal Year 2025 Certifications and Assurances for the FTA Assistance Programs in which Nevada County participates for Transit Services operations.

Transit Services Division staff has completed the necessary document, and it is ready to be executed by the Chair of the Nevada County Board of Supervisors.

Staff recommends the Board approve the Resolution.
