**BACKGROUND:**

Currently, there is one Consumer Member vacancy for a Nevada County Representative for a three-year term ending June 30, 2027, along with one Public Member position and two Consumer Member positions for unexpired three-year terms beginning July 1, 2026, and ending June 30, 2029. This authority provides for the delivery of the In-Home Supportive Services Program (IHSS) in the counties of Nevada and Sierra. For further information contact, (530) 274-5601. These vacancies were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers bulletin board, the Board of Supervisors office, and the County website. Notice was also posted at the Truckee Town Hall and the District V Board of Supervisors office in Truckee.

Nathalie Ennis submitted an application for reappointment to the Nevada-Sierra Connecting Point Public Authority Governing Board as a Consumer Member representative on June 5, 2026. Nathalie was first appointed to the position on December 15, 2020, and is a member in good standing.

Nikki Bowden submitted an application for reappointment to the Nevada-Sierra Connecting Point Public Authority Governing Board as a Consumer Member

representative on June 17, 2026. Nikki was first appointed to the position on October 10, 2017, and is a member in good standing.

Sandra Lindsey submitted an application for reappointment to the Nevada-Sierra Connecting Point Public Authority Governing Board as a Public Member representative on June 2, 2026. Sandra was first appointed to the position on June 28, 2022, and is a member in good standing.
