WHEREAS, the Board of Supervisors of the County of Nevada, on March 10, 2026, adopted Resolution 26-071, amending Resolution 25-326 allocating positions to various county departments; and

WHEREAS, the Board of Supervisors of the County of Nevada, on April 14, 2026, adopted Resolution 26-125, amending Resolution 25-326 allocating positions to various county departments; and
