**BACKGROUND:**

Currently there are four positions and six vacancies on the Nevada County Sanitation District No. 1 Advisory Committee. These positions were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers Bulletin Board, in the Board of Supervisors Office, at the Madelyn Helling Library, and on the County website. Notice was also posted at Grass Valley Library, Truckee Library, Truckee Joseph Center, the Truckee Town Hall, and the District V Board of Supervisors office in Truckee.

Mr. Terry Thies and Mr. Howard Stone have submitted applications to be reappointed to the Nevada County Sanitation District No. 1 Advisory Committee. Mr. Thies has served on the committee since May 24, 2011 and Mr. Stone has served on the committee since June 24, 1997.
