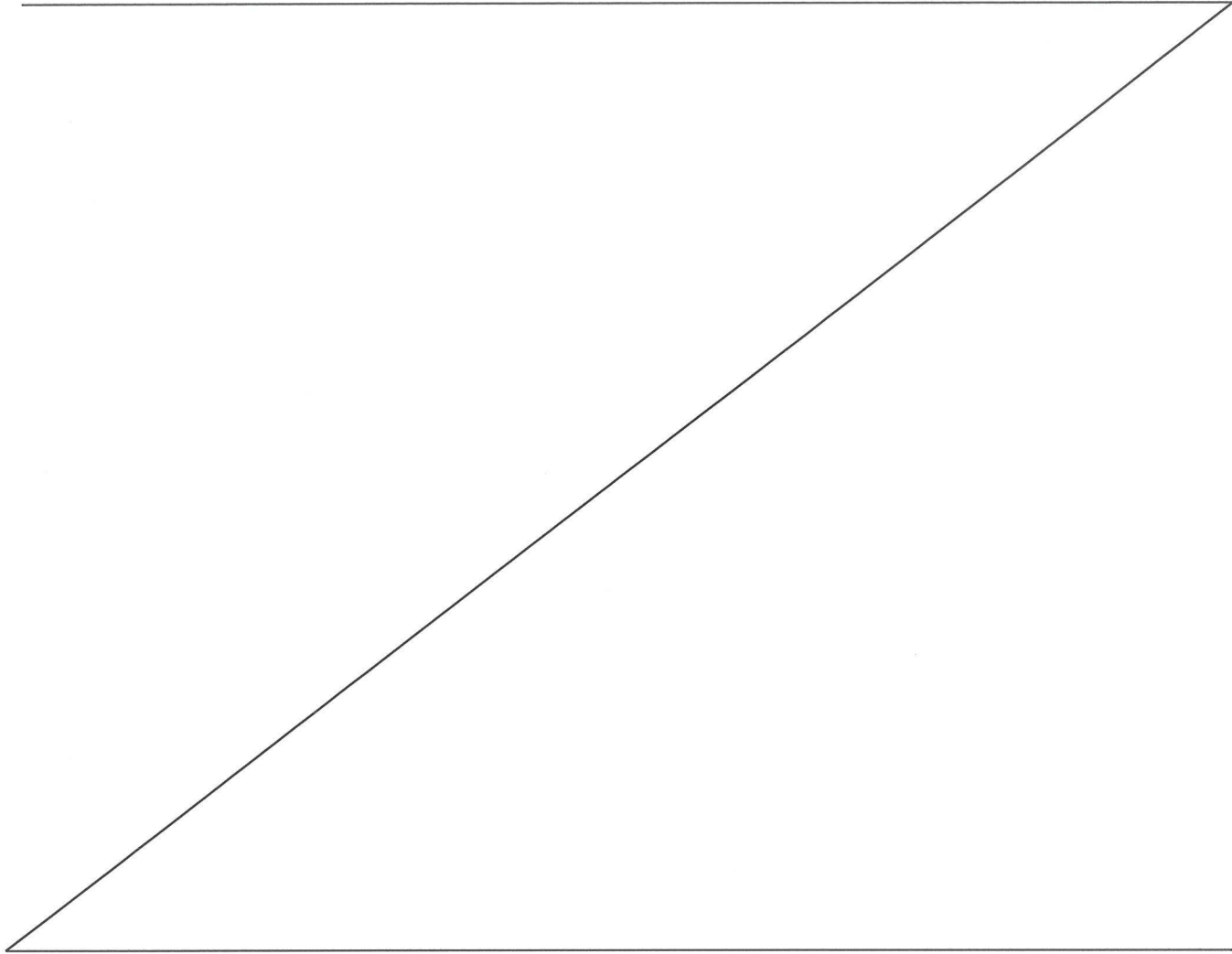
WHEREAS, said Contract was for the Eric Rood Administration Center Helling Crosswalk Project in accordance with the plans and specifications; and


