WHEREAS, construction documents were prepared and approved through Resolution 23-598 for the project known as the Demolition of Damaged Former DOT Buildings; and

WHEREAS, the County of Nevada entered into a Standard Public Works Contract with GW Demolition, Inc. (of Rio Linda, CA) through Resolution 24-179, totaling a not-to-exceed amount of \$195,655 including a 10% contingency; and

WHEREAS, said Contract was for the Demolition of the damaged former DOT building Project in accordance with the plans and specifications; and

WHEREAS, said improvements were completed to the satisfaction of the Nevada County Building Department and the Chief Information Officer on June 15, 2024, with final contract costs totaling \$180,241.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Accepts the work as being completed.
- 2. Directs the Clerk of the Board to release the Bond for Labor and Materials on July 28, 2024 and the Bond of Faithful Performance on June 28, 2025.
- 3. Directs the Clerk of the Nevada County Board of Supervisors to record this notice in accordance with Civil Code Section 9208.

BE IT FURTHER RESOLVED THAT the Auditor-Controller is hereby authorized and directed to release and pay the 5% retention thirty-five (35) days after of the recording of the Notice of Completion, or no later than sixty (60) days after completion of the project as defined in PCC Sec. 7107, whichever occurs first, to assure that there are no Stop Payment notices filed against the project.
