RESOLUTION APPROVING AMENDMENT NO. 6 TO THE CONTRACT BETWEEN THE COUNTY OF NEVADA AND NELSON ENGINEERING, FOR PROFESSIONAL ENGINEERING SERVICES, INCREASING THE AMOUNT OF THE CONTRACT BY \$40,000, TO A NEW MAXIMUM AMOUNT NOT TO EXCEED \$90,000

WHEREAS, on July 1, 2017, the Nevada County Purchasing Agent issued a contract to Nelson Engineering, in the amount of \$25,000 for On-Call Professional Engineering; and


WHEREAS, the contract was renewed on July 23, 2018, July 1, 2019, September 9, 2020, June 15, 2021, and increased to \$50,000 on September 15, 2021; and

WHEREAS, additional services are required for processing land development projects, cannabis permits, and miscellaneous engineering service; and

WHEREAS, sufficient budget is available to fund this contract amendment in account codes:

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors of the County of Nevada, State of California approves Amendment No. 6, attached hereto, to the professional services contract by and between the County of Nevada and Nelson Engineering, increasing the contact amount by \$40,000 for a maximum not to exceed amount of \$90,000 and the Chair of the Board of Supervisors is hereby authorized to execute Amendment No. 6. and authorizes the Purchasing Agent to encumber the contract amount.

THIS AMENDMENT is executed this 8th day of March, 2022, by and between Nelson Engineering and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled Nelson Engineering On-Call Engineering Services executed on July 20, 2017, and which Agreement was subsequently amended on:

06/15/21 renewal 4

09/15/21 increase of \$25,000 – Total Contract not to exceed \$50,000

WHEREAS, the parties desire to amend their agreement to allow or provide for an additional Fourty Thousand Dollars (\$40,000.00) for a not to exceed amount of ninety Thousand Dollars (\$90,000) through June 30, 2022; and

NOW, THEREFORE, the parties hereto agree as follows:

- 1. This amendment shall be effective as of March 8, 2022
- 2. That the Maximum Contract Price set forth at Fifty Thousand Dollars (\$50,000) is increased by Fourty Thousand Dollars (\$40,000.00) for the new not to exceed Contract amount of Ninety Thousand Dollars (\$90,000.00).
- 3. That in all other respects the prior agreement of the parties as previously amended shall remain in full force and effect except as amended herein.
