OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 1 TO THE CONTRACT BETWEEN THE COUNTY OF NEVADA AND UNIVERSAL SECURITY SERVICES DBA: ALLIED UNIVERSAL SERVICES (RES. 20-321), INCREASING THE CONTRACT AMOUNT TO \$255,235, AND EXTENDING THE TERM THROUGH AUGUST 31, 2021

WHEREAS, County has contracted security guard services both armed and unarmed to supplement County staffing needs at facilities which require additional security and protection; and

WHEREAS, the current Contract expired on June 30, 2021; and

WHEREAS, Invitation for Bid No. 143030 was issued to solicit bids for County-wide security services; and

WHEREAS, the current incumbent Universal Security Services dba: Allied Universal Services has agreed to provide a continuation of services at the same price, terms and conditions until the Bid process was complete and through August 31, 2021.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors of the County of Nevada:

1. Approves the increase in contract amount by \$ 46,000 for the new not-to-exceed amount of \$255,235;
2. Approves a contract extension for a term beginning July 1, 2021 through August 31, 2021;
3. Authorizes the Board Chair to execute Amendment No. 1 to the contract with Allied Universal Services; and
4. Authorizes the Auditor's Office to encumber the funds.

**AMENDMENT NO.1 TO CONTRACT NO. BFS20-321 WITH
UNIVERSAL PROTECTION SERVICES dba: ALLIED UNIVERSAL SECURITY SERVICES**

THIS AMENDMENT is executed this 24th day of August 2021 by and between Universal Protection Services dba: Allied Universal Security Services and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled Security guard services at various locations for the Health and Human Services Agency executed on July 28, 2020 by Board authorized Contract BFS20-321

WHEREAS, the parties desire to amend their agreement to allow or provide for a two (2) month contract extension, increase in coverage for services as needed, and an increase to the contract in the amount of \$46,000 for the revised not to exceed amount of \$255,235; and

WHEREAS, the original contract was executed on July 28, 2020 and approved by Resolution No. 20-321 in the not to exceed amount of \$209,235.

NOW, THEREFORE, the parties hereto agree as follows:

1. This amendment shall be effective as of July 1, 2021.
2. That the contract term shall be extended to August 31, 2021.
3. That the Schedule of Services, Exhibit "A" shall be revised to include "as needed" services at the same price, terms and conditions of the existing Contract.
4. That the maximum contract amount be increased by \$46,000 to a new maximum contract amount of \$255,235.
6. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
