



RESOLUTION No. 17-136

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 1 TO THE PERSONAL SERVICES CONTRACT (PESK3200) BETWEEN THE COUNTY OF NEVADA AND SCRAM OF CALIFORNIA, INC TO INCREASE THE MAXIMUM AMOUNT OF THE CONTRACT TO \$50,000 FOR FISCAL YEAR 2016/2017, AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE AMENDMENT

WHEREAS, the County of Nevada entered into a one year personal services contract with SCRAM California, Inc. for the provision of continuous remote electronic monitoring for alcohol consumption in the amount of \$20,000, executed on June 27, 2016 per Purchase Order Number PESK3200; and

WHEREAS, the number of probationers in need of continuous remote alcohol monitoring has grown significantly; and

WHEREAS, the Chief of Probation wishes to increase the maximum contract amount in order to provide services to additional participants; and

WHEREAS, the parties now desire to amend the contract to increase the maximum amount of the contract.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors, of the County of Nevada that Amendment No. 1 to the Personal Services Contract between the County of Nevada and SCRAM of California, Inc. increasing the maximum contract amount from \$20,000 to \$50,000, be and hereby is approved, and the Chair of the Board of Supervisors is hereby authorized to execute Amendment No. 1 on behalf of the County of Nevada.

All services are funded by the Substance Abuse Mental Health Services Administration (SAMHSA) grant for the contract term of July 1, 2016 through June 30, 2017. Funds to be disbursed from 0101-20320-201-1000 / 521520 not to exceed the maximum contract amount of \$50,000.

BE IT FURTHER RESOLVED, that the Nevada County Board of Supervisors hereby directs the Auditor-Controller to encumber an additional \$30,000 for Fiscal Year 2016/17.

**AMENDMENT #1 TO PERSONAL SERVICES CONTRACT NO. PESK3200
WITH SCRAM OF CALIFORNIA, INC.**

THIS AMENDMENT is executed this 10th day of March 2017 by and between SCRAM OF CALIFORNIA, INC. and the COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled Continuous Remote Alcohol Monitoring for Probation clients via the use of SCRAM equipment executed on June 27, 2016.
