OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING THE SUBMITTAL OF AN APPLICATION FOR FUNDING AND THE EXECUTION OF A GRANT AGREEMENT AND ANY AMENDMENTS THERETO PERTAINING TO THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) CORONAVIRUS RESPONSE ROUND 1 (CDBG-CV1) FUNDING

WHEREAS, the California Department of Housing and Community Development (HCD) announced the availability of approximately \$18.7 million in funding for the Community Development Block Grant (CDBG) Coronavirus Response Round 1 (CDBG-CV1) funding for local assistance; and

WHEREAS, this CDBG-CV1 funding is made available pursuant to the Coronavirus Aid, Relief, and Economic Security (CARES) Act; and

WHEREAS, on July 31, 2020, the Health and Human Services Agency/Housing Division held a virtual meeting to solicit recommendations for eligible CDBG-CV1 grant funding activities, upon which community comments and proposals were received and subsequently reviewed and evaluated for program eligibility, community need and impact; and

WHEREAS, upon review and evaluation of community comments and determination of community need and impacts, this CDBG-CV1 funding is recommended to be solicited to benefit eligible members of the Community who fall within the Low-Moderate (Low-Mod) income group (LMI) in the form of homeless assistance and mortgage assistance needs resulting from the COVID 19 pandemic; and

WHEREAS, the CDBG-CV1 application deadline is August 31, 2020, and the Health and Human Services Agency (HHSA) wishes to apply for this funding; and

WHEREAS, upon authorization and approval by the Board of Supervisors HHSA will prepare and submit an application in the amount of up to \$257,134, the maximum available for Nevada County; and

WHEREAS, upon receipt of a grant agreement, the Director of Health and Human Services will return to the Board of Supervisors for acceptance of the grant, at which time the Director of Health and Human Services, or designee, sign the standard agreement with the State of California for the purposes of this grant.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors of the County of Nevada, State of California, hereby authorizes the submittal of one or more application(s) in the aggregate amount of \$257,134 for the following CDBG-CV1 activities, pursuant to the January 2020 CDBG NOFA and the Board authorizes as follows:

SECTION 1:

SECTION 4:

If the application is approved, the Director of Health and Human Services, or designee, is authorized to enter into and sign the grant agreement and any subsequent amendments thereto with the State of California for the purposes of this grant.

SECTION 5:

Upon receipt of a grant agreement, the Director of Health and Human Services will return to the Board of Supervisors for acceptance of the grant, at which time the Director of Health and Human Services, or designee, sign the standard agreement with the State of California for the purposes of this grant.

SECTION 6:

If the application is approved, the Director of Health and Human Services or designee, is authorized to sign Funds Requests and other required reporting forms.
