Why provide a lactation accommodation?



It's the law.

The PUMP Act, part of the federal Fair Labor Standards Act (FLSA), requires employers to provide a private non-bathroom space for breastfeeding employees to pump. Some states have [additional requirements](#).

It's good for business.

In one study, 83 percent of employees felt more positive about their company after lactation benefits were offered.¹ For every \$1 spent on wellness support programs (including lactation spaces) employers see \$2-\$3 return.²

It has public health benefits.

Breastfeeding has health benefits for both mothers and babies. Employees who receive break time and a private space to pump are more than twice as likely to be breastfeeding at six months.³

It contributes to an inclusive culture.

Mamava pods are a strong symbol of your organization's support for breastfeeding parents and help create an inclusive environment.

How many lactation spaces do you need?

The National Institute of Health recommends six for every 1,000 female employees, two for 250 female employees, and one for 100 employees.
