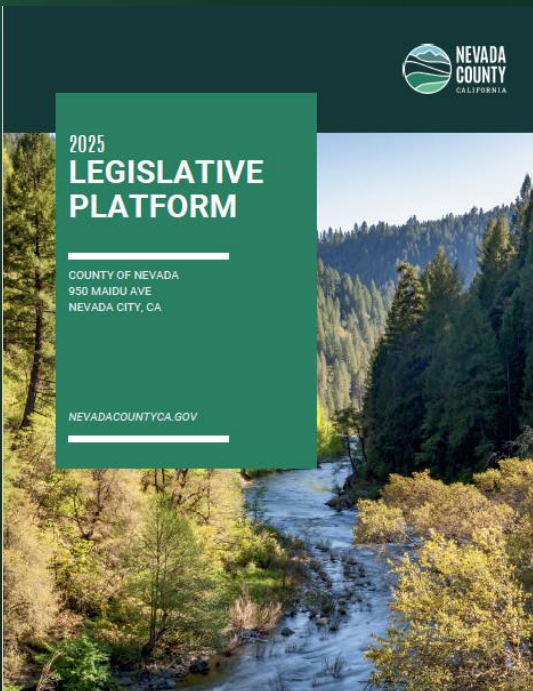

Executive Branch Actions

- **Executive Orders / OMB Memo Funding Freeze**
 - Federal Funding Freeze for grants and loans
 - STOP WORK ORDER – National Forest Foundation
- **Department of Government Efficiency (DOGE)**
 - Reduction of Workforce / Elimination of Staff



Congressional Branch Actions

- **FY24/25 Budget – Continuing Resolution**
 - Potential Government Shutdown (3/15)
 - Congressional Designated Funding Projects
- **Budget Reconciliation – Entitlement / Mandatory Funding**
 - Proposed Mandatory Spending Cuts
 - Medicaid
 - Supplemental Nutrition Assistance Program (SNAP)
 - Social Services Block Grant (SSBG)
 - Temporary Assistance for Needy Families (TANF)
 - Inflation Reduction Act (IRA) clean energy tax credits

Potential Impacts of Proposed Actions

29% Residents of Nevada County Impacted

(1 out of every 4 residents)

- 2022 - \$219M in Nevada County via Medicaid and Children's Health Insurance Program (CHIP)
- SNAP (CalFRESH) 11,768 Nevada County Residents (11.5%)
- 47.7% SNAP participants are older adults and children

Temporary Assistance to Needy Families (TANF) (CalWorks)

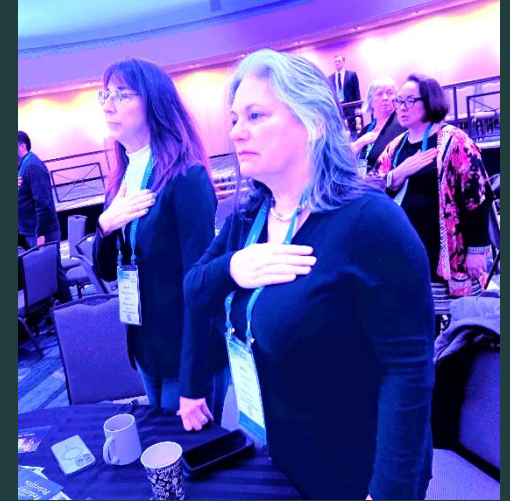
- 842 individuals receiving TANF benefits

Other Programs at Risk

- Women, Infants and Children (WIC); Maternal Child Health Programs – 1,175 participants
- County Contracts and Nonprofit Organizations

Potential Impacts – Veteran Services

- Regional Veterans Affairs Office staff have retired
- Staffing for the Veterans Crisis Hotline eliminated
- VA Medical Centers and outpatient clinics
- Homeless outreach eliminated
- Veteran Readiness and Employment outreach eliminated
- Travel reimbursement for VA appointments are frozen
- Significant additional policy changes at the federal level

Key Issues & Highlights

- Federal Action is Warranted – Need for Hearings
- Insurance Premiums must reflect risk mitigation work at individual, community and landscape levels – lowering risk by 40-60%
- Crisis extends beyond homeowners – Public Housing at jeopardy
- Mortgage-backed security financial market creeping toward risk
- California State Association of Counties (CSAC) Policy Recommendations
- Tactical Solutions with bipartisan support
