OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

AUTHORIZING RESOLUTION THE **EXECUTION** AMENDMENT NO. 3 TO THE PERSONAL SERVICES CONTRACT WITH CALIFORNIA FORNESIC MEDICAL GROUP, INC. FOR MEDICAL, MENTAL HEALTH AND DENTAL SERVICES AT THE ADULT CORRECTIONAL FACILITIES IN NEVADA COUNTY, EXTENDING THE CONTRACT TERM TO JUNE 30, 2027, AND INCREASING CONTRACT BY A THE **MAXIMUM** \$9,633,777.78 FOR A TWO-YEAR PERIOD AND INCREASES THE TOTAL NOT TO EXCEED AMOUNT TO \$28,051,913.53

WHEREAS, one of the mandated responsibilities of the Nevada County Sheriff's Office is to provide correctional services for the County and provide inmates with medical, mental health and dental care pursuant to Tile 15 of the California Code of Regulations; and

WHEREAS, the California Forensic Medical Group, Inc. (CFMG) has been the County's provider of medical, mental health and dental care in its correctional facilities for years and in 2020 entered into a new contract with CFMG beginning January 1, 2021 through July 30, 2024 (Resolution 20-508) which allowed for two (2) 2-year options to renew; and

WHEREAS, on May 9, 2023 via Resolution 23-187, the Board of Supervisors approved Amendment No. 1 to the contract providing greater staff flexibility by allowing the employment of Licensed Vocational Nurses (LVNs) in addition to Registered Nurses and increased the contract amount by \$171,503 to a total not to exceed amount of \$13,899,671.00; and

WHEREAS, on August 6, 2024 via Resolution 24-424, the Sheriff's Office and CFMG extended the contract by one (1) year to June 30, 2025, incorporating revised Exhibits A, B, and C to the contract, and increased the maximum contract amount by \$4,518,464.75 to a total not to exceed amount of \$18,418,135.75, with a continued one (1) 2-year option to renew; and

WHEREAS, the Sheriff's Office and CFMG desire to extend the contract by two (2) years to June 30, 2027, revising Exhibits A, B, and C to the contract, to reflect mandates by the CalAIM Justice Involved Iniaitive, and to increase the maximum contract amount by \$9,633,777.78 to a total not to exceed amount of \$28,051,913.58.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors, of the County of Nevada, State of California, that the Chair of the Board of Supervisors be and is hereby authorized to execute, on behalf of the County of Nevada, Amendment No. 3 to the personal services contract with the California Forensic Medical Group Inc., entitled Medical, Mental Health and Dental Services for the Adult Correctional Facilities in Nevada County, amending Exhibit A,

Exhibit B, and Exhibit C and revises the contract total not to exceed amount to \$28,051,913.53 as detailed in Amendment No. 3 to the Contract and extending the contract term to June 30, 2027.
