## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF THE STANDARD AGREEMENT NO. 20-HCFC-00028 BETWEEN THE STATE OF CALIFORNIA BUSINESS, CONSUMER SERVICES, AND HOUSING AGENCY AND THE COUNTY OF NEVADA TO PROVIDE SUPPORT TO CONTINUUMS OF CARE, LARGE CITIES, AND COUNTIES TO PROTECT THE HEALTH AND SAFETY OF HOMELESS POPULATIONS AND REDUCE THE SPREAD OF THE COVID-19 OUTBREAK, IN THE MAXIMUM AMOUNT OF \$74,408 AND AUTHORIZING AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE HEALTH AND HUMAN SERVICES AGENCY HOUSING AND COMMUNITY SERVICES DIVISION'S BUDGET FOR FISCAL YEAR 2019/20 (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, COVID-19 has become a global pandemic that poses a significant threat the health and well-being of all Nevada County residents; and

WHEREAS, homeless members of the Nevada County community are at an increased risk of contracting and spreading COVID-19; and

WHEREAS, homeless residents lack the necessary permanent dwelling to shelter in place and to properly maintain regular daily hygiene necessary, contributing to a heightened risk of contracting COVID-19; and

WHEREAS, the State of California has made available 100 million dollars in funding to Counties and Continuum of Care organizations in the state to fight the spread of COVID-19 within the homeless population through temporary shelters, medically-indicated services and supplies, and enhancements to existing shelter facilities; and

WHEREAS, Nevada County has been allocated \$74,408.00 of this funding for these COVID-19 prevention and containment efforts.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Standard Agreement Number 20-HCFC-00028 by and between the County and the Business, Consumer Services, and Housing Agency in the amount of \$74,408.00 for COVID-19 prevention and containment efforts within the homeless population of Nevada County be and hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors authorizes the Director of Child Support Services/Collections and Housing & Community Services to execute the Agreement on behalf of the County of Nevada.

BE IT FURTHER RESOLVED that the Auditor-Controller is authorized and directed to amend the Health and Human Services Agency Housing and Community Services Division's Budget for Fiscal Year 2019/20 as follows:
