



RESOLUTION No. 24-285

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 5 TO THE CONTRACT BETWEEN THE COUNTY OF NEVADA AND GENUINE PARTS COMPANY FOR THE VENDOR MANAGED INVENTORY PARTS FACILITY OPERATIONS TO INCREASE THE CONTRACT AMOUNT BY \$100,000 FOR A NOT TO EXCEED TOTAL OF \$984,773 FOR FISCAL YEAR 2023/24

WHEREAS, the Nevada County Board of Supervisors (“Board”) approved and adopted Resolution 21-273 awarding a contract for a Vendor Managed Inventory Parts Facility Operations (“Agreement”), with the ability to execute three (3) additional annual renewals beginning July 1, 2022; and

WHEREAS, the Board approved Amendment No. 1 by Resolution 22-226 to approve transferring the Agreement from Riebes Auto Parts, LLC to Genuine Parts Company and increase fiscal year 2021/22 contract to a not to exceed \$740,000; and

WHEREAS, the Board approved Amendment No. 2 by Resolution 22-265 approving the first annual renewal of a one-year term from July 1, 2022, through June 30, 2023, with a not to exceed annual contract amount of \$780,000; and

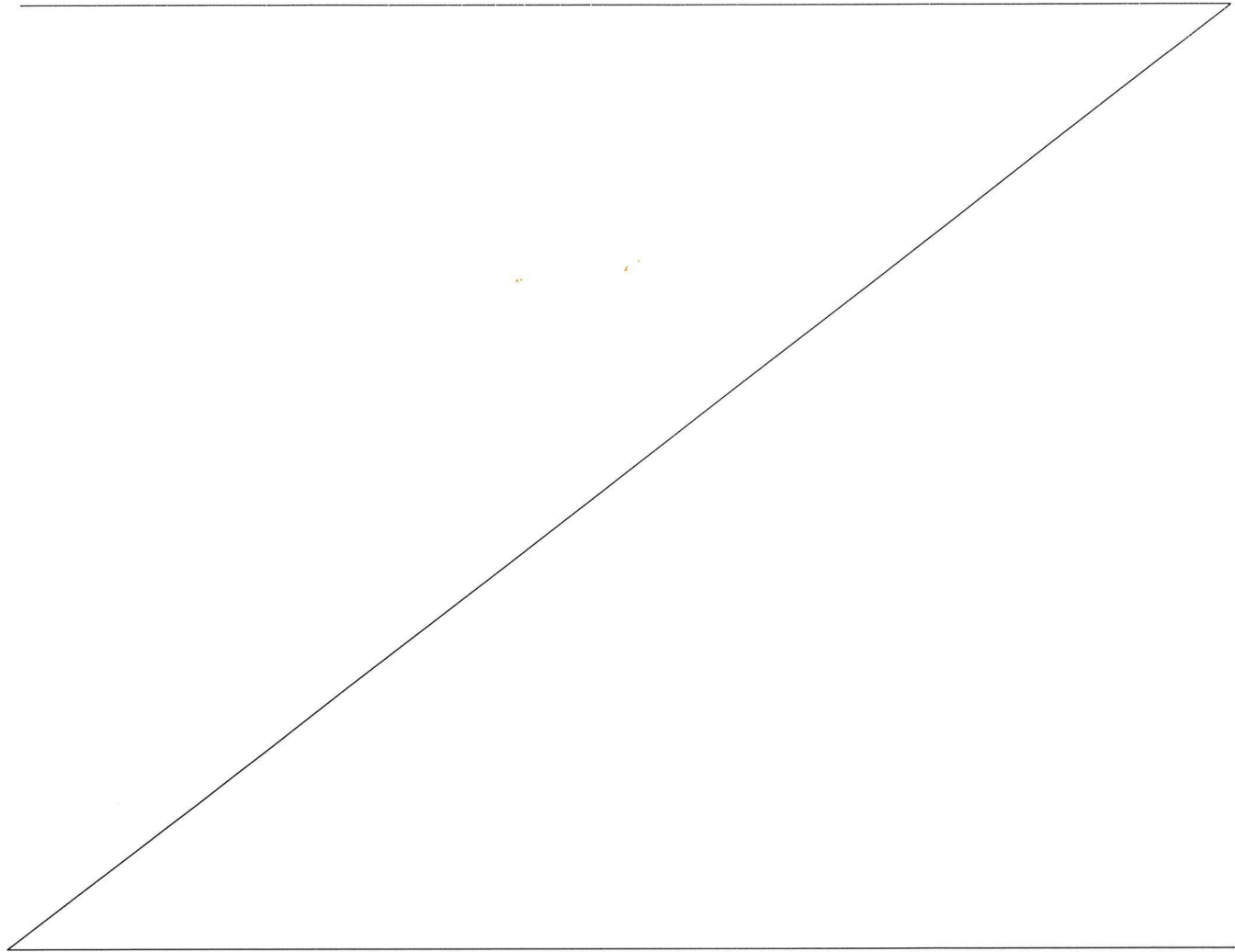
WHEREAS, the Board approved Amendment No. 3 by Resolution 23-271 to increase fiscal year 2022/23 contract by \$210,000 for a total not to exceed \$990,000; and

WHEREAS, the Board approved Amendment No. 4 by Resolution 23-322 approving the second annual renewal of a one-year term from July 1, 2023, through June 30, 2024, with a not to exceed annual contract amount of \$884,773; and

WHEREAS, Amendment No. 5 with Genuine Parts Company will increase the contract by \$100,000 for an annual not to exceed total amount of \$984,773 for fiscal year 2023/24.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Approves Amendment No. 5 to the contract and authorizes the Chair of the Board of Supervisors to execute the Amendment between the County of Nevada and Genuine Parts Company for the Vendor Managed Inventory Parts Facility Operations.
2. Authorizes the Auditor Controller to encumber the amended total contract amount to: 4291-92005-704-2000/ 520900 \$984,773.

**AMENDMENT No. 5 TO CONTRACT BM321273 WITH
GENUINE PARTS COMPANY**

THIS AMENDMENT is executed this 11TH day of June, 2024, by and between the County of Nevada and Genuine Parts Company. Said Amendment will amend the prior agreement between the parties entitled Vendor Managed Inventory Parts Facility Operations executed on June 22, 2021, by Resolution No. 21-273, and which Agreement was subsequently amended on May 24, 2022, by Resolution No. 22-226, June 14, 2022, by Resolution No. 22-265, June 13, 2023, by Resolution No. 23-271, and on June 27, 2023, by Resolution No. 23-322.

WHEREAS, increase in the cost or parts, larger than anticipated repair projects and upgrades to heavy equipment necessitates an increase of the contract amount by one hundred thousand dollars (\$100,000) for an annual not to exceed total amount of nine hundred eighty four thousand seven hundred seventy three dollars (\$984,773) for FY 2023/24.

NOW, THEREFORE, the parties hereto agree as follows:

1. This amendment shall be effective as of May 1, 2024.
2. The contract amount will be increased by one hundred thousand dollars (\$100,000), for a total annual not to exceed amount of nine hundred eighty four thousand seven hundred seventy three dollars (\$984,773).
3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
