OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 1 TO THE RENEWAL CONTRACT WITH RESTPADD HEALTH CORP., RED BLUFF, FOR THE PROVISION OF 24-HOUR LOCKED ACUTE PSYCHIATRIC SERVICES FOR RESIDENTS OF NEVADA COUNTY WHO MEET CRITERIA FOR 5150 PLACEMENT TO REVISE EXHIBIT "B", SCHEDULE OF CHARGES AND PAYMENTS TO REFLECT THE INCLUSION OF AN ACUITY RATE. THE CONTRACT MAXIMUM REMAINS THE SAME AT \$1,900,000 FOR THE TERM OF JULY 1, 2025, THROUGH JUNE 30, 2027 (RES. 25-215)

WHEREAS, on June 3, 2025 per Resolution 25-215 the Nevada County Board of Supervisors approved the execution of the renewal Contract with Restpadd Health Corp., Red Bluff to provide 24-hour locked acute psychiatric services for residents of Nevada County who meet criteria for 5150 placement which allows the continuation of essential, mandated services for medically necessary inpatient services to eligible residents of Nevada County who have a mental illness and / or emotional disturbances that require acute psychiatric hospitalization services; and

WHEREAS, the parties desire to amend Exhibit "B" Schedule of Charges and Payments to add an acuity rate with no change to Contract maximum. It is recommended that the Board approve this Amendment adding an up to \$400 a day acuity rate for additional staffing and cost of property damage on a case-by-case basis; and

WHEREAS, this amendment will ensure continued access to a critical residential resource for Nevada County adults in need of mental health care, and the placement is uniquely equipped to support individuals with high-acuity needs requiring additional staffing and services.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Amendment to the Professional Services Contract by and between the County and Restpadd Health Corp., Red Bluff, pertaining to the provision of 24-hour locked acute psychiatric services for residents of Nevada County who meet criteria for 5150 placement in the maximum amount of \$1,900,00 for the contract term of July 1, 2025 through June 30, 2027, be and hereby is approved, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.

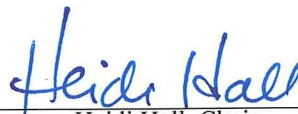

**AMENDMENT NO. 1 TO THE CONTRACT WITH
RESTPADD HEALTH CORP (RES 25-215)**

THIS AMENDMENT is executed this September 23, 2025, by and between RESTPADD HEALTH CORP, hereinafter referred to as "Contractor" and COUNTY OF NEVADA, hereinafter referred to as "County." Said Amendment will amend the prior agreement between the parties entitled Professional Services Contract, executed on June 3, 2025, per RES No. 25-215; and

WHEREAS, the Contractor provides 24-hour locked Acute Psychiatric Services for residents of Nevada County who meet criteria for 5150 placement for the Nevada County Behavioral Health Department; and

WHEREAS, the parties desire to amend their Agreement to amend Exhibit "B" Schedule of Charges and Payments to reflect the inclusion of an acuity rate.

NOW, THEREFORE, the parties hereto agree as follows:

1. That Amendment #1 shall be effective as of July 1, 2025.
2. That the Schedule of Charges and Payments, Exhibit "B" is amended to the revised Exhibit "B" attached hereto and incorporated herein.
3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.

EXHIBIT "B"
SCHEDULE OF CHARGES AND PAYMENTS
RESTPADD HEALTH CORP. - RED BLUFF

The maximum amount of this contract shall not exceed \$1,900,000 for the entire contract term of July 1, 2025 through June 30, 2027; \$950,000 for FY 2025/26 and \$950,000 for FY 2026/27.

COUNTY agrees to pay at the all-inclusive rate of:

FY 2025/26

\$1,236 per day for indigent and Medi-Cal patients who are 18 years old or older, excluding day of discharge

\$1,494 per day for patients under the age of 18 years, excluding day of discharge

Up to \$400 per day acuity rate increase for additional staffing and cost of property damage by client on a case by case basis with approval required by County after review of documentation of need.

FY 2026/27

\$1,279 per day for indigent and Medi-Cal patients who are 18 years old or older, excluding day of discharge

\$1,546 per day for patients under the age of 18 years, excluding day of discharge

Up to \$400 per day acuity rate increase for additional staffing and cost of property damage by client on a case by case basis with approval required by County after review of documentation of need.

CONTRACTOR shall submit monthly to COUNTY, an invoice and supporting documentation as required by County. COUNTY shall pay CONTRACTOR at the established provisional rates within (30) days of receipt of monthly patient billing invoice supporting documentation, provided the contract amount has not been exceeded. Should the County be notified in writing that an adjustment to the rates has been made and the effective date of such adjustment, then County shall pay Contractor the adjusted rate.

CONTRACTOR is hereby informed that COUNTY payment may be delayed for lack of appropriate records and/or contents of those records required from CONTRACTOR in order to bill under Medi-Cal guidelines.

County shall bill clients according to their liability as established by County and/or any third party payors (e.g. Medi-Cal, Medicare, private insurance) identified by County.

Within ninety (90) days after the close of the fiscal year, CONTRACTOR shall provide COUNTY with an annual Cost Report in the appropriate format for submission to the State of California, Department of Health Care Services for Medi-Cal reimbursement.
