WHEREAS, on August 16, 2016, the Board approved the award of the construction contract for the Penn Valley Pipeline Project; and


WHEREAS, this contract amendment will provide an additional scope of work to provide Engineering Services during construction which were included in the RFP issued on November 19, 2012 titled "Design Services for the Connection of the Penn Valley Sewer System to the Lake Wildwood Wastewater Treatment Plant Improvement Project"; and

WHEREAS, the cost of Engineering Services during construction is \$204,330; and

WHEREAS, there are sufficient funds available to fund this contract in budget code 4772-91005-709-2000/540710.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Sanitation District No. 1 Board of Directors:

- 1. Amends the Contract with HydroScience Engineers, Inc. for Engineering Services During Construction for the Connection of the Penn Valley Sewer System to the Lake Wildwood Wastewater Treatment Plant Improvement Project. The contract term shall be extended to April 30, 2018, and the Maximum Contract Price shall be increased by \$204,330.00 for a total contract price of \$807,761.00.
- 2. Authorizes the Chair of the Board of Directors to execute on behalf of Nevada County Sanitation District No. 1 the agreement between the Sanitation District and HydroScience Engineers, Inc.

Amendment Description: As part of the engineering services during construction (ESDC) contract currently pending board approval, Coastland Engineers has requested HydroScience provide additional ESDC associated with the following additive bid alternatives:

- Additive Bid Alternate A Lift Station Odor Control Unit,
- Additive Bid Alternate B Lake Wildwood Odor Control Unit,
- Additive Bid Alternate C Lake Wildwood Grit Removal Unit,
- Additive Bid Alternate D Penn Valley Collection System Improvements, and
- Additive Bid Alternate F Lake Wildwood Piping Improvements

- Additional participation in the final inspection walkthrough (PPE)
- Bi-weekly progress conference calls (up to 4 additional 2-hour calls each for HSE and PPE)
- Construction site visit (up to 2 additional visits for HSE and 1 additional visit for PPE)
- Preparation of record drawings

Assumptions:

- Submittals and RFI will be transmitted electronically in PDF file format. Prior to submittal to HydroScience, the District's construction manager shall perform an initial review of the submittal for completeness and return obviously incomplete submittals to the Contractor.
- Agendas and minutes for the meetings and summaries of the site visits will be prepared by the District or their program manager.
- The record drawings will be based on the Contractor's red line markups during the construction.

Deliverables: Submittal review response forms; RFI response forms; draft change order request review comments and record drawings associated with the Additive Bid Alternatives that will be included in construction.

Fee Adjustment: The increase in cost for these services is \$48,500, broken down as follows:

These additional services will be billed on a not-to-exceed (NTE) basis.
