



# RESOLUTION No. 01-476

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

**RESOLUTION FOR AUTHORIZING ACCESS TO SALES AND USE TAX RECORDS PURSUANT TO REVENUE AND TAXATION CODE SECTION 7056**

**THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA HEREBY RESOLVE AS FOLLOWS:**

**Section 1.** The Board of Supervisors hereby requests the State Board of Equalization to permit the following County officials or their designee, to the extent allowed by law, to receive and review sales and use tax records from the State Board of Equalization.

**Section 2.** The County of Nevada hereby certifies that Hinderliter, de Llamas and Associates:

- A. Has an existing contract with the County of Nevada to examine sales and use tax records; and
- B. Is required by that contract to disclose information contained in, or derived from, those sales or transactions and use tax records only to an officer or employee of the County who is authorized by this resolution to examine the information; and
- C. Is prohibited by that contract from performing consulting service for a retailer, engaged in business in the State of California during the term of that contract; and
- D. Is prohibited by that contract from retaining the information contained in, or derived from those sales tax or use tax records, after that contract has expired.

D. Is prohibited by that contract from retaining the information contained in, or derived from those sales tax or use tax records, after that contract has expired.

**Section 3.** Information obtained by examination of the State Board of Equalization records shall be used only for purposes related to the collection of local sales and use taxes by the Board for municipal revenue forecasting and verification.

**Section 4.** This resolution supersedes all previous authorizations, including Resolution 99438.

**Section 5.** By adoption of this resolution, the Board of Supervisors hereby grants consent and authorizes access to Sales and Use Tax Records as set forth above. The Nevada County Board of Supervisors shall provide notification to the State Board of Equalization by forwarding a certified copy of this resolution to:


