Public Comment 3/23/2021

Homelessness, poverty, and lack of access to basic health care and mental health treatment resulted in the tragic shooting incidents in which Sage Crawford and Gabriel Strickland lost their lives at the hands of Sheriff's Deputies. There is much public concern regarding Nevada County law enforcement personnel not adhering to excessive use of force and de-escalation training as required by California State law.

Nevada County Law enforcement personnel, (sheriff's deputies and correctional officers, dispatch personnel, and police officers) must hold the required California Police Officer's Standards & Training (POST) certificate. They must also be current on updated State (POST) requirements on excessive use of force and de-escalation training and maintain these certifications.

In order to promote public trust and transparency the District Attorney must release thoroughly researched and accurate investigative reports regarding both shooting incidents to the public in a timely manner following the event. The report must include the training certificates of the sheriff's deputies, police officers and dispatch personnel and an analysis of whether excessive use of force and de-escalation training was followed during the incident. The DA's office must also release the incident reports of each officer, the incident reports of their supervisors, as well as any disciplinary reports the officers may have received in these incidents or any previous incidents.

I am requesting that the Board of Supervisors hold a special law enforcement forum to publicly address these issues.
