



# RESOLUTION No. 25-065

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

**RESOLUTION APPROVING EXECUTION OF A PARTICIPATION AGREEMENT TO AUTHORIZE NEVADA COUNTY TO PARTICIPATE IN THE CALIFORNIA MENTAL HEALTH SERVICES AUTHORITY CREDENTIALING AND RE-CREDENTIALING FOR CALIFORNIA COUNTY BEHAVIORAL HEALTH PLANS PROGRAM FOR THE PROVISION OF CREDENTIALING, RE-CREDENTIALING, AND MONTHLY MONITORING FOR THE TERM OF MARCH 1, 2025 THROUGH JULY 31, 2026 IN THE MAXIMUM AMOUNT OF \$65,800 AND AUTHORIZING AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE BEHAVIORAL HEALTH DEPARTMENT'S BUDGET FOR FISCAL YEAR 2024/25 (4/5 AFFIRMATIVE VOTE REQUIRED)**

WHEREAS, the State and Centers for Medicare and Medicaid Services (CMS) have published various uniform provider credentialing and recredentialing requirements that County mental Health Plans and Drug Medi-Cal Organized Delivery Systems (DMC-ODS) must follow; and

WHEREAS, the Nevada County Behavioral Health Department has entered into a contract with the California Mental Health Services Authority (CalMHSA) Semi-Statewide Electronic Health Record Program for the services related to a California-centric Electronic Health Record (EHR); and

WHEREAS, CalMHSA is a Joint Power Authority representing County Behavioral Health Departments under the authority of the Government Code; and

WHEREAS, CalMHSA has developed a process for services related to the credentialing process, which may include registration, certification, licensure, and/or professional association membership, along with ongoing monthly monitoring of provider databases and exclusion lists. Credentialing ensures that providers are licensed, registered, waived, and/or certified as required by state and federal law; and

WHEREAS, the Nevada County Behavioral Health Department intends to enter into a contract with CalMHSA for Credentialing and Recredentialing to meet state and federal credentialing and re-credentialing requirements.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Participation Agreement by and between the CalMHSA, pertaining to the provision of the CalMHSA credentialing and re-credentialing services for the contract term of March 1, 2025 through June 31, 2026, in the maximum amount of \$65,800 be and hereby is approved, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Agreement on behalf of the County of Nevada and authorizes and directs the Auditor-Controller to release \$32,900 of fund balance in Fund 1589 and amend Behavioral Health's budget as follows:

Fiscal Year 2024/25

Revenue: 1589-40103-493-1000 / 446250 \$32,900

Expenditure: 1589-40103-493-1000 / 521520 \$65,800
