



RESOLUTION No. 26-042

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING A BUDGET AMENDMENT FOR NEVADA COUNTY ELECTIONS TO REFLECT STATE REVENUE RECEIVED FOR THE NOVEMBER 4, 2025, STATEWIDE SPECIAL ELECTION AND ASSOCIATED EXPENSES (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, on August 21, 2025, the Governor approved Senate Bill 280, which provided funding to each California County's Elections department for the November 4, 2025, Statewide Special Election; and

WHEREAS, each county's elections department submitted a cost estimate for the November 4, 2025, Statewide Special Election. Nevada County Elections requested \$695,200, which was received in the Nevada County Elections Revenue Category RC62000; and

WHEREAS, Senate Bill 280, requires that funds be used to pay for the November 4, 2025, Statewide Special Election and provides that "any excess funds received by the county shall be used to offset state costs for the next statewide election conducted by the county"; and

WHEREAS, the calculated cost related to the administration of the November 4, 2025, Statewide Special Election is \$525,645.82; and

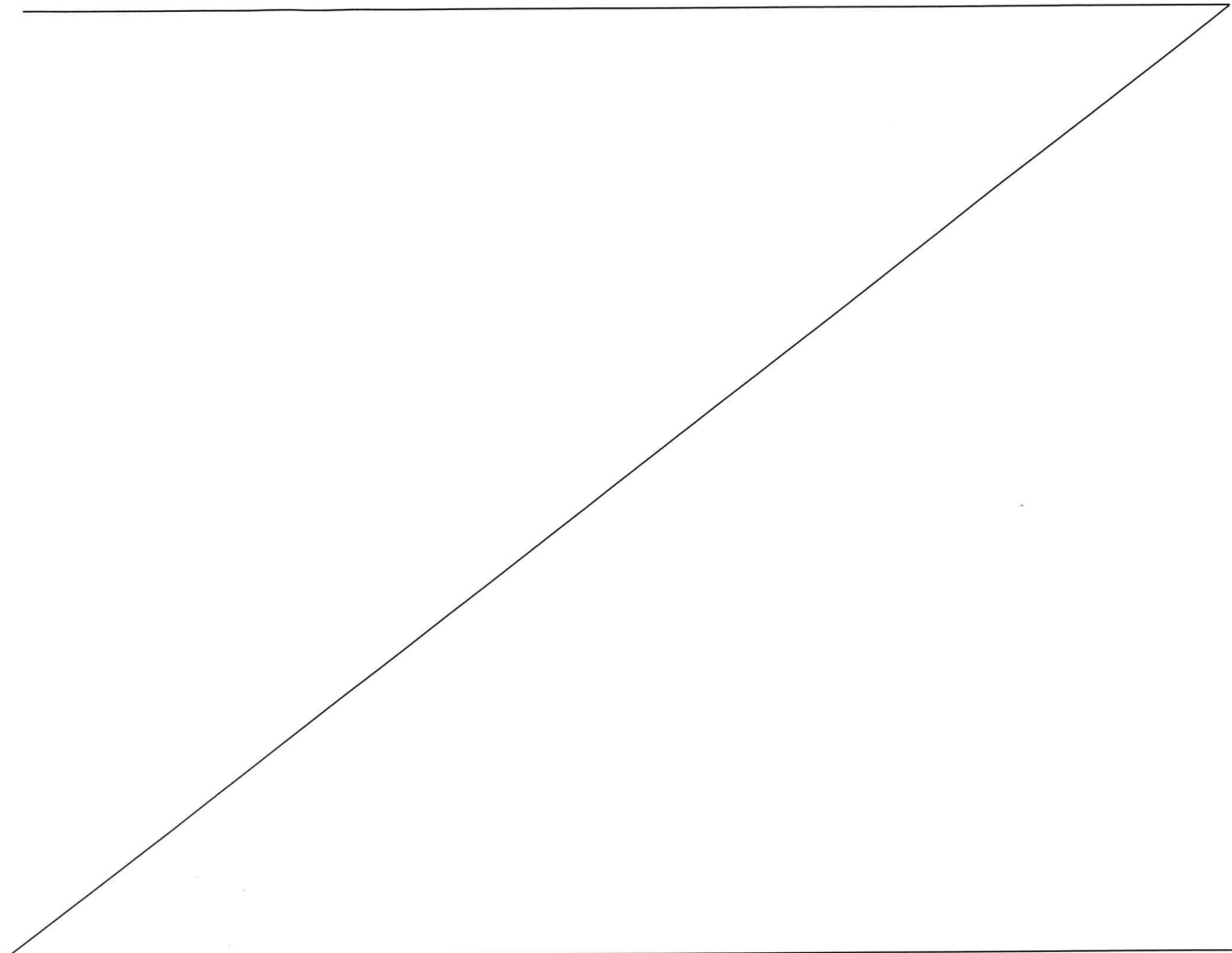
WHEREAS, on February 10, 2026, the Nevada County Board of Supervisors approved a budget amendment to account for \$45,000 of these revenues and expenses which are not included in this amendment; and

WHEREAS, since the November 4, 2025, Statewide Special Election was not accounted for in the original budget due to its special circumstance, this budget amendment recognizes the remaining funds of \$650,200 to account for Statewide Special Election costs and for certain other new costs to prepare for the administration of the next statewide election conducted by the county.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors, of the County of Nevada, State of California, that the Auditor-Controller is directed to amend the Nevada County Elections Fiscal Year 2025/26 budget (4/5 affirmative vote required) as follows:
