



RESOLUTION No. 22-332

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION AUTHORIZING TRANSFER OF A SURPLUS VEHICLE TO THE WASHINGTON COUNTY WATER DISTRICT (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, Purchasing Policy Section 9, Nevada County Administrative Code Section A-1V 1.4(B) and Government Code Section 25504, County departments shall transfer excess property to the Purchasing Division. Purchasing shall sell, transfer, donate, dispose of, or exchange surplus property as provided by Nevada County Code, Government Code, and Board of Supervisors' direction; and

WHEREAS, Section 25365 of the California Government Code authorizes the Board of Supervisors to dispose of surplus property by transfer to state, city, district, etc. by four-fifths vote; and

WHEREAS, pursuant to Resolution 19-460 the Board of Supervisors has designated vehicle No. 26769 to be surplus and not required for County use; and

WHEREAS, the Washington County Water District has requested the donation of such vehicle for fuel economy driving from the Washington area into Nevada City and Grass Valley for business demands; and

WHEREAS, the Fleet vehicle has been fully depreciated and will be transferred to the General Fund to allow for the donation to Washington County Water District.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of Nevada County, California that:

1. Approves by four-fifths majority vote the donation of surplus county property vehicle No. 26769 to the Washington County Water District
2. Acknowledges that the County Purchasing Agent published notice of the intended donation pursuant to section 25365 of the Government Code and that no public comments or objections that warrant Board reconsideration were received during the publication period.
