OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NUMBER 5 TO THE AGREEMENT BETWEEN THE COUNTY OF NEVADA AND PARATRANSIT SERVICES FOR THE PROVISION OF SPECIALIZED PARATRANSIT SERVICES IN WESTERN NEVADA COUNTY

WHEREAS, on May 14, 2013, the Nevada County Board of Supervisors adopted Resolution 13-168, approving a five-year contract with Paratransit Services for provision of specialized Paratransit Services in western Nevada County that began on July 1, 2013 and will expire on June 30, 2018; and

WHEREAS, on July 22, 2014, the Nevada County Board of Supervisors adopted Resolution 14-362 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, on August 11, 2015, the Nevada County Board of Supervisors adopted Resolution 15-392 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, on July 26, 2016, the Nevada County Board of Supervisors adopted Resolution 16-381 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, on October 11, 2016, the Nevada County Board of Supervisors adopted Resolution 16-491 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, the contract agreement contains a provision for an annual increase of the Paratransit Services contract price that includes both a fixed vehicle service hourly rate and a fixed monthly rate on July 1st of each contract year equivalent to the increase in the CPI (California Consumer Price Index, California Department of Industrial Relations, Division of Labor Research, All Urban Consumers) for the most recent available twelve month period prior to each scheduled increase in an amount of not less than one percent (1%), with a cap of three percent (3%) annually; and

WHEREAS, the California CPI calculation for the twelve month period of April 2016 through April 2017 reports a 3.0 percent increase; and

WHEREAS, Nevada County and Paratransit Services wish to amend the contract agreement to include an increase of the Paratransit Services' fixed vehicle service hourly rate to \$37.48 and the fixed monthly rate to \$59,966 per the applicable annual CPI effective July 1, 2017 through Fiscal Year 2017/18; and

WHEREAS, there is sufficient budget available to fund this contract in the Fiscal Year 2017/18 budget code 4281-91003-707-1000 521520.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Approves the attached Amendment to increase the Paratransit Services' fixed vehicle service hourly rate to \$37.48 and the fixed monthly rate to \$59,966 through Fiscal Year 2017/18 in the contract agreement.
- 2. Authorizes the Chair of the Board of Supervisors to execute on behalf of Nevada County the amendment between Nevada County and Paratransit Services.

AMENDMENT NO. 5

PARATRANSIT SERVICES CONTRACT

THIS AMENDMENT is executed this 15th day of August, 2017, by and between PARATRANSIT SERVICES and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled Personal Services Contract between County of Nevada and Paratransit Services for Provision of Specialized Paratransit Services in western Nevada County, executed on July 1, 2013, by Resolution No. 13-168 and which agreement was subsequently amended on July 22, 2014, by Resolution Number 14-362, on August 11, 2015, by Resolution Number 15-392 and on July 26, 2016, by Resolution No. 16-381, by Resolution No. 16-491

NOW, THEREFORE, the parties hereto agree as follows:

- 1. To increase the Paratransit Services' fixed vehicle service hourly rate to \$37.48 and the fixed monthly rate to \$59,966 from July 1, 2017 through FY2017/18.
- 2. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
